Municipal Ordinance No. 13, S. 1980

AN ORDINANCE TO ISSUE CASH TICKETS IN THE AMOUNT OF TWO (P2.00) PESOS TO EACH STALLHOLDER IN THE PUBLIC MARKET EVERY MARKET DAY IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

SPONSORED BY: Honorable Benjamin Taasan  
SECONDED BY: Unanimously

SECTION 1 - An Ordinance To Issue Cash Tickets In The Amount Of Two (P2.00) Pesos To Each Stallholder In The Public Market Every Market Day In The Municipality Of Tigbauan, Province Of Iloilo.

SECTION 2 - All stallholders in the Public Market of Tigbauan, Iloilo shall pay the amount of two (P2.00) pesos for a corresponding cash ticket to be issued by a duly authorized collector of the Municipal Treasurer’s Office every market day.

SECTION 3. Violators of this ordinance shall be punished with a penalty of twenty (P20.00) pesos or an imprisonment of two (2) days or both at the discretion of the honorable court.

SECTION 4 - This Municipal Ordinance shall take effect upon approval.
