COMMITTEE REPORT NO. 2019-016

TO: The Honorable Presiding Officer and the Members of the August Body

SUBJECT: re: Result of Public Hearing on Draft Municipal Ordinance No. 2019-003- "Aedes-Borne Diseases Prevention And Control Ordinance Of The Municipality Of Tigbauan"

"FINDINGS/CONCLUSIONS:

A Public Hearing was conducted on March 25, 2019 at 1:30 in the afternoon at the Tigbauan Covered Gym, Tigbauan, Iloilo with the presence of the following:

- SB Doc Suzette Marie Hilado-Banno,- Proponent:, Dr. Josefa Monserate, MHO, Mrs. Juanita Tudence and Mrs. Juana Gangoso, both Sanitary Inspectors II, MHO;*
- Principals/School Heads/representatives of Primary, Elementary, Secondary public and private schools, this municipality;*
- Punong Barangays, Brgy. Kagawad Chairpersons Committee on Health and Sanitation, BHWs, representatives of every barangay, this municipality.*

Discussion of the provisions of Draft Municipal Ordinance No. 2019-003 comprising of 11 sections were discussed thoroughly.

- Message by Dr. Josefa T. Monserate, Municipal Health Officer IV, LGU-Tigbauan;*
 - First of all, she thanked the sponsor, Hon. Suzette Marie Hilado-Banno, for this Ordinance will make our Municipality one of the top ten municipalities to have this ordinance if this will be approved later on.*
 - Informed that from Jan. 2019 to date, there are already 30 cases of Dengue which made Tigbauan ranked No. 19th municipality with the most number of Dengue cases in the whole Province of Iloilo;*
 - re: the two (2) other Aedes-borne Diseases, the Zika & Chikungunya diseases, so far there are no reported cases yet in Tigbauan;*

- Comments/Suggestions relative to Draft Municipal Ordinance No. 2019-003*

During the exhaustive discussion, the following comments, suggestions were noted down:

Mr.. Efren Gonzalez (Brgy. 6, Pob.) – suggested to request the Municipal Engineering Office to speed up the repair/construction of drainage in their barangay (which started in January 2019 yet) to avoid standing/stagnant water, which is the main breeding places of the larvae of Aedes mosquitoes, since the rainy season is fast approaching;

Hon. Banno made an assurance to relay the request of Mr. Gonzalez to the Municipal Engineering Office so that the Engineering Office could follow-up such drainage project with the Contractor in charge of the project.

- The Municipal Aedes-Borne Diseases Task Force and Prevention Team (Section 3) & Barangay Aedes-Borne Diseases Task Force and Prevention Team (Section 5) will be created.*

Punong Barangay Lorna Domingo of Brgy. 1 (Pob.) – opined that it is sufficient for the Barangays to adapt this Municipal Ordinance and there is no need to pass a separate Brgy. Ordinance; to achieve the purpose of preventing and controlling the Aedes-borne Diseases, P.B. Domingo believes that every household should be encouraged to observe this Ordinance (specially to abide with the Aedes- Borne Diseases programs and activities such as the 4:00 o'clock P.M. habit, the 4S contra Dengue, to adapt the "kaya-kulob" approach..etc..);

Mrs. Hermenia Tualdon (Principal I- METES) – discussed her concern on the possibility of misinterpreting Sec. 9.b (Any person who shall fail to observe the 4:00 o'clock PM habit;) because she has observed that a lot of people misunderstood RA 9003 (otherwise known as the Philippine Solid Waste Management Act) and the 4:00 o'clock P.M. habit. For them, 4:00 o'clock P.M. habit means cleaning and burning the collected wastes/ garbage.

Dr. Monserate – explained that in the 4:00 o'clock P.M. habit, our constituents are urged to clean up (to include the “kaya-kulob” approach without burning...) at 4:00 o'clock P.M. since this is the peak biting time of Dengue biting mosquitoes; indiscriminate fogging and burning of garbage is NOT allowed or is prohibited and the persons responsible are liable.

It was also discussed that an hour every Friday for the month of June to August shall be allotted for the clean-up of households and barangay premises which is the 4 o'clock P.M. habit.

If there is an impending outbreak of Dengue, 4 o'clock PM habit should be done everyday and should be implemented by the respective Barangay Task Force and Prevention Team.

After all these suggestions and queries, it seemed that everyone present was in accord & very supportive to pass this Ordinance for the well-being of our constituents in our Municipality.

RECOMMENDATIONS:

The Committee hereby recommends to calendar for second reading the Draft Municipal Ordinance No. 2019-003. **AEDES-BORNE DISEASES PREVENTION AND CONTROL ORDINANCE OF THE MUNICIPALITY TIGBAUAN**
