SUBJECT: *Problems/Concerns of Barangay 8 Poblacion Residents Affected by Storm Surge (as Stated in the Letter of Punong Barangay Elena Titular Dated September 18, 2019)*

#### **FINDINGS AND DISCUSSIONS:**

1. That the residents who are aware of the 20-meters easement from the shoreline and suppose not to build permanent houses but because of having no lot and further livelihood they built their house at their own risk;
2. In Sitio Tangkungan, being the catch basin and the location is very low that's why every time it rains the said place is under water.

#### **RECOMMENDATIONS:**

The committee hereby recommends for the following:

1. Residents whose houses are located along the seashore must just temporarily build shanties or temporary huts for their fishing activities;
2. That starting henceforth if possible transfer to safer place not vulnerable for danger of storm surge, flood and other calamities;
3. That they should comply to whatever advisory or warnings given to them for their own safety;
4. For Sitio Tangkungan under water problem, it was recommended to the Office of the Mayor to fund for the construction of the drainage system.

The Committee further recommends for the adoption and approval of this Committee Report.
