• **COMMENTS/SUGGESTIONS** relative to Draft Municipal Ordinance No. 2019-008

During the exhaustive discussion, there were no negative reactions/feedbacks from the participants. Despite some changes or increased fees and charges made, (*particularly under Chapter V - Fishery Rentals, Fees and Charges on the different Fishing Zones of this Municipality and under Chapter IV- Permit Fee for Occupation/Calling Not Requiring Government Examination*), generally, the fees, charges and taxes were acceptable to them, although there were a few clarifications and queries raised by some participants (...mostly, queries/clarifications by some Punong Barangays on the issuance of barangay clearances and permits, on the need to pass their own barangay ordinance or revenue code, queries by some market vendors on the proposed code's coverage & computations on fees/charges/business tax as well as other queries on matters relative to the impositions of fees, charges and business taxes as reflected in the proposed revenue code).

The resource persons/department managers also announced and invited the participants to feel free to visit their respective offices in case they still have other concerns or matters to be clarified regarding this proposed measure.

Ms. Elma Tionsay, the Municipal Treasurer also emphasized that pursuant to the BLGF rules/circulars, in case this municipal revenue code will be approved on the last quarter of 2019, the fees, charges and business taxes will be implemented only on the 2nd quarter of 2020 (*starting April 1 of 2020*), which means that from January 1, 2020 to March 31, 2020, the old rates will still apply.

It was observed that everyone present seems to be in accord & very supportive to pass this Revenue Code for the good and welfare of the constituents of this Municipality.

"RECOMMENDATIONS:

"In view of the foregoing discussion, the Committee respectfully recommends to pass an ordinance ordaining the Revised Revenue Code of the Municipality of Tigbauan.

The Committee further recommends the adoption and approval of this Committee Report."
