COMMITTEE REPORT NO. 2019-040

TO: The Honorable Presiding Officer and the Members of the August Body

SUBJECT: re: Result of Public Hearing on Draft Ordinance No. 2019-009 - "2019 Health & Sanitation Code Of The Municipality of Tigbauan, Province of Iloilo"

"FINDINGS/ DISCUSSION:

1.) *Public Hearing for the proposed Health and Sanitation Code of the Municipality of Tigbauan, Province of Iloilo started at 1:20 in the afternoon, on November 29, 2019 at the Conference Room, Tigbauan Municipal Building, Tigbauan, Iloilo, attended by Hon. SB Member Reynaldo Tumabotabo, Resource Persons: Dr. Josefa T. Monserate, MHO and Mrs. Juana Gangoso, Municipal Sanitary Inspector, Punong Barangays, Barangay Kagawads of the Committee on Health and Sanitation, DepEd Heads/Principals or their representatives and Department Heads of LGU Tigbauan and others.*

2.) *First, the 9 important Codes of the Municipality of Tigbauan were explained and that we need to pass these Codes or make updates to the Codes that we already have.*

3.) *The proposed Code of Health and Sanitation Public Hearing started with Chapter I – The Definition of Terms, which we didn't give too much emphasis on.*

4.) *Chapter II is regarding Health.*

In this Chapter, it was more on reviewing the 14 Ordinances we have on Health including the new Ordinance: Annual General Physical Examination of the Municipal Employees. We could see on the faces of the participants that they know these Ordinances.

5.) *Chapter III deals with Sanitation.*

Since we didn't have our Municipal Sanitation Code, we patterned ours from the Provincial Sanitation Code. Dr. Josefa T. Monserate, MHO and Mrs. Juana Gangoso, Municipal Sanitary Inspector, helped explained the Sanitation topics.

The most important aspect of this Sanitation Chapter is the necessity of procuring a Sanitary Permit for all kinds of businesses and getting a Health Certificate for anybody who will work in a Food or Non-Food establishment from the Municipal Health Officer (MHO).

The Municipality of Tigbauan shall ensure and support the promotion of health, sanitation and hygiene, and the preservation of comfort and convenience of their residents.

6.) *After the Sanitation Chapter was explained, we opened up a Question and Answer portion. Most of the questions were about the Rabies Control Ordinance (Ordinance No. 2009-003) and they were geared towards the Agriculture Dept. since our part of the Ordinance is more on the Prevention and Treatment of Rabies only.*

I informed the participants that I will talk with the Head of the Agriculture Dept., Mrs. Eugenia Sayson and Staff, and ask her to arrange a meeting with the present Public Hearing participants, SB on Agriculture and SB on Health and Sanitation to upgrade, update or amend the said Ordinance.

Lastly, the participants were informed that after this Health and Sanitation Code of the Municipality of Tigbauan, Province of Iloilo would have been passed, soft copies of this Code will be distributed to all Punong Barangays, all School Heads and all concerned individuals.

Public hearing ended at 2:45 P.M.


RECOMMENDATIONS:
