COMMITTEE REPORT NO. 2020-026

TO: The Honorable Presiding Officer and the Members of the August Body

SUBJECT: re: Barangay Atabayan Revenue Ordinance No. 001, Series of 2020 - "An Ordinance Adopting The Barangay Revenue Code Of Barangay Atabayan, Municipality Of Tigbauan, Province Of Iloilo."

"FINDINGS/DISCUSSIONS:

a.) The ordinance was accordingly presented in a public hearing and is consistent with the provisions of Section 391 of the Local Government Code, to wit:

"SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;*
- (2) Enact tax and revenue ordinances, subject to the limitations imposed in this Code;*
- (7) Regulate the use of multi-purpose halls, multi-purpose pavements, grains or copra dryers, patios and other post-harvest facilities, Barangay waterworks, Barangay markets, parking areas of other similar facilities constructed with government funds within the jurisdiction of the Barangay and charge reasonable fees for the use thereof;*
- (14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;*
- (24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;*

b.) That said Barangay Revenue Code was valid and legal and is in accordance with the provisions of the Local Government Code.

RECOMMENDATIONS:


- *In view of the foregoing findings, the Committee respectfully recommends for the passage of a resolution declaring barangay Atabayan ordinance as **valid and legal**.*
- *The Committee further recommends the adoption and approval of this Committee Report."*


