### COMMITTEE REPORT NO. 2020-027

TO: The Honorable Presiding Officer and the Members of the August Body

SUBJECT: re: Result of Public Hearing on Draft Municipal Ordinance No. 2020-009-“ *An Ordinance Prescribing The Temporary Fare Rates For Tricycles Operating Within The Territorial Jurisdiction Of The Municipality Of Tigbauan, Iloilo For The Period Covered By Community Quarantine And New Normal*”

#### “FINDINGS/DISCUSSIONS:

- Title of the Ordinance was changed to “An Ordinance Prescribing The Temporary Fare Rates For Tricycles **And Trisikads** Operating Within The Territorial Jurisdiction Of The Municipality Of Tigbauan, Iloilo, For The Period Covered By Community Quarantine And New Normal,” considering that provision for fare rate for trisikads was added.
- The said ordinance is applicable only for the period covered by community quarantine and new normal.
- This ordinance is composed of 11 sections and was discussed per section for comments and recommendations.
- Section 1 indicates the minimum fare rate of Php15.00.
- Section 2 indicates the proposed fare matrix of TEDOA Route with no correction.
- Section 3 indicates the proposed fare matrix of PBTODA Route with the following corrections:
  - Bolocaue (Boundary) shall be deleted because it is under the TTODA Route
  - Cansilayan and Supa fare rate shall be changed **to Php35.00** from proposed Php 40.00;
- Section 4 indicates fare matrix of TTODA Route with no correction.
- Section 5 indicates fare matrix of STCTODA Route with the following corrections:
  - Bitas proposed Php20.00 to **Php 15.00**
  - Napnapan Sur/Norte proposed Php 25.00 to **Php 20.00**
  - Nasuli and Bangkal proposed Php35.00 to **Php30.00**
  - Inclusion of **Sitio Dalucutan with Php 30.00 fare**
  - Inclusion of **Brgy Bantud** and **Olo Barroc** in the Special Trip Areas.
- Section 6 indicates fare matrix of NBBA Route with no correction.
- Section 7 additional provision for Trisikad fare matrix**
  - Regular fare of Php10.00 from Public market to any point in the poblacion except in the following:
 

<b>1. Public Market to</b>	TNHS	Php15.00
	Slaughterhouse	Php15.00
	ILECO	Php15.00
	MTCC/Bearland	Php15.00
<b>2. TNHS to</b>	ILECO	Php20.00
	MTCC/Bearland	Php20.00
- Section 8 indicates the procedure on the issuance of fare matrix.
- Section 9 is the repealing clause, Section 10, the Separability Clause and Section 11, is the effectivity clause with no corrections.
- The fare rate for Cargoes/baggage shall be referred to Municipal Ordinance 2019-003 and 20% for Senior Citizens, PWDs and students shall be observed.

14. The 1 passenger for trisikads and 3 passengers for tricycles shall be strictly observed together with the wearing of face mask and physical distancing both for private and public vehicles (trisikads and tricycles).

**RECOMMENDATIONS:**

*In view of the foregoing findings, the Committee respectfully recommends to:*

1. Incorporate in the draft ordinance the positive suggestions, corrections and recommendations given by the participants during the public hearing.
2. To schedule for 2<sup>nd</sup> reading the proposed" Draft Ordinance No. 2020-009, "An Ordinance Prescribing The Temporary Fare Rates For Tricycles **And Trisikads** Operating Within The Territorial Jurisdiction Of The Municipality Of Tigbauan, Iloilo, For The Period Covered By Community Quarantine and New Normal.
3. The Committee further recommends for the adoption and approval of this Committee Report.
