SUBJECT: re: Letter dated September 9, 2020 of Atty. Suzette T. Alquisada, Municipal Mayor addressed to the Sangguniang Bayan thru: Hon. Virgilio T. Teruel, Vice Mayor & Presiding Officer, respectfully requesting for the passing of a *“Resolution Authorizing The Municipal Mayor, Atty. Suzette T. Alquisada, For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With Philippine Charity Sweepstakes Office (PCSO) For The Grant Of Lotto And STL Shares As Well As Calamity Assistance To The Municipality Of Tigbauan.”*

“FINDINGS:

- 1.) *A committee meeting was conducted on October 5, 2020 at 9:15 A.M. at the SB Session Hall with the presence of the following: Mr. Ryan Avelino, Assistant Branch Manager/Acting Branch Head PCSO, Hon. Jerry T. Tuares, Chairman Committee on Games & Amusement, Hon. Suzette Marie Hilado-Banno, Chairman, Committee on Women, Family, Social Services & Senior Citizens (Including Indigents), and other Committee Members: Hon. Marlon R. Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Mrs. Lowella Taran, MSWDO.*
- 2.) *Mr. Ryan Avelino, Assistant Branch Manager/Acting Branch Head, Philippine Charity Sweepstakes Office (PCSO) discussed the requested Memorandum of Agreement (MOA) between the Municipality of Tigbauan and Philippine Charity Sweepstakes Office (PCSO) for the grant of Lotto and STL Shares as well as Calamity Assistance to the Municipality Of Tigbauan.*
- 3.) *For Lotto Charity Fund, PCSO is mandated to give five percent (5%) share of the Charity Fund generated from the sale of Lotto within the jurisdiction of LGU every six (6) months while for Small Town Lottery(STL) it is given every month although PCSO is still silent on the percentage of sharing because they are still waiting for the IRR from the final action of the President.*
- 4.) *An Example of the share we have received, the Charity Fund Share of LGU Tigbauan was Forty Seven Thousand Eight Hundred Sixty Five Pesos & 26 Cents (P47,865.26) from the Lotto draws for the period of July-December 2018 with Check No. 398097 dated July 31, 2019.*
- 5.) *It is good that we will pass this MOA to have transparency for future releases of PCSO shares to LGU Tigbauan.*
- 6.) *As to the Calamity Assistance to the Municipality of Tigbauan, Hon. Marlon Teruñez inquired if we can request for a new ambulance. Mr. Avelino responded that he will send the needed requirements to have one and hopefully, we can have it in January 2021.*


