FINDINGS & CONCLUSION:

The above-mentioned subject matter was indorsed to the Sanggunian on September 29, 2020, by Ms. Myra Gene G. Gautier, OIC-Municipal Budget Officer for the review and authorization of this August Body. In the said Indorsement, the OIC-Municipal Budget Officer has pre-reviewed the CY 2020 SK Annual Budget and in her opinion, such show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations.

Upon the review of the committee, it was found out that the amount (as hereunder provided) was budgeted in accordance with the provisions of the Local Government Code of 1991 as well as the utilization of the 20% Development Fund pursuant to Joint Memorandum Circular No. 2011-01 dated April 13, 2011 by the DILG and the DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto, specifically RA 10121 (Philippine Disaster Risk Reduction and Management Act of 2010);

Brgy. Cordova Norte CY 2020 SK Annual Budget Involving an Appropriation of P462,643.24, 10% General Fund in the amount of P246,818.70, approved by the Sangguniang Kabataan on September 28, 2020.

RECOMMENDATIONS:

1. That the disbursement from the subject Annual Budget shall be in accordance with Joint Memorandum Circular No. 2011-01 Series of 2011 by the DILG and DBM dated April 13, 2011, Executive Orders, Issuances, Rules and Regulations.
2. That the SK Annual Budget may be considered valid and operative on the dates of their effectivity.
3. That compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit.
4. A Resolution shall be passed by the SB conforming and approving the CY 2020 SK Annual Budget of Barangay Cordova Norte.

The Committee further recommends for the adoption and approval of this Committee Report.”
