SUBJECT: Letter dated October 6, 2020 of Atty. Suzette T. Alquisada, Municipal Mayor addressed to the Sangguniang Bayan thru: Hon. Virgilio T. Teruel, *Vice Mayor & Presiding Officer*, respectfully requesting for the passing of a *“Resolution Authorizing The Municipal Mayor, Atty. Suzette T. Alquisada, For And In Behalf Of The Municipality of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With Philippine Red Cross (PRC) To Avail The Membership Accidental Assistance Benefits (MAAB) Program For All Registered Barangay Tanods In the Municipality Of Tigbauan”*

“FINDINGS:

- 1.) A committee meeting was conducted on October 12, 2020 at 9:00 A.M. at the SB Session Hall with the presence of the following: Mr. John Lester Tiquio, *MDRRM Head*, Hon. Jerry T. Tuares, *Chairman Committee on Barangay Affairs*, Hon. Suzette Marie Hilado-Banno, *Chairman, Committee on Women, Family, Social Services & Senior Citizens (Including Indigents)*.
- 2.) This Memorandum of Agreement (MOA) is for the renewal of the MAAB insurance of Barangay Tanods, Municipal Disaster Risk Reduction Management (MDRRM) Personnel and Citizens Crime Watch Members (CCW) thru Philippine National Red Cross (PRC).
- 3.) The Philippine National Red Cross (PRC), thru its Prudential Guarantee Accidental Insurance provides its members this accident insurance.
- 4.) The good feature of this insurance is that PRC provides trainings on Disaster Risk Reduction Management (DRRM), First Aid, Search and Rescue, Disaster Preparedness among others and responds to incidents and calamities when circumstances warrants. These trainings were not implemented this year due to the pandemic.
- 5.) It has been three (3) years that these employees have been enjoying this insurance coverage and there was no Memorandum of Agreement (MOA) until this time.
- 6.) The Municipality of Tigbauan agrees to avail of PRC's Membership Accidental Assistance Benefits (MAAB) program for its old members and for the new ones.
- 7.) The Budget comes from 70% Preparedness of the 5% MDRRM Budget for CY 2020.
