SUBJECT: *Re: Sangguniang Panlalawigan Resolution No. 2020-649- "Resolution Urging The Component Local Government Units In The Province Of Iloilo To Revisit, Reassess And Recalibrate Their Disaster Risk Reduction Plans Amidst The COVID-19 Pandemic," and Sangguniang Panlalawigan Resolution No. 2020-650- "Resolution Reminding the Component Local Government Units in the Province of Iloilo to Update Their Municipal Disaster Risk Reduction and Management Plans Amidst the Covid-19 Pandemic" Sangguniang Panlalawigan Resolution No. 2020-651- "Resolution Reminding The Component Local Government Units In The Province Of Iloilo To Update Their Ordering Agreements Or Acceptance/Acquisition Of Relief Goods Intended For Natural Disasters Amidst The COVID-19 Pandemic"*

FINDINGS AND DISCUSSIONS:

- 1.) On S.B. Session dated October 21, 2020 the above-named SP Resolution No. 2020-649 and SP Resolution No. 2020-650 were referred jointly to the Committee on Peace and Order and Public Safety and Committee on Health and Sanitation for study and recommendation. And SP Resolution No. 2020-651 was referred jointly to the Committee on *Women, Family, Social Services and Senior Citizens (Including Indigents)*, Committee on Peace and Order and Public Safety and Committee on Barangay Affairs also for study and recommendation.
- 2.) As provided under paragraph RESOLVED FURTHER of said above-named three (3) SP Resolutions, component LGU's in the Province of Iloilo shall be furnished copies thereof thru this August Body for their information and appropriate action.
- 3.) There is a need for the MDRRM Office (*under the guidance and supervision of the MDRRM Council*) of this municipality to prepare and render responses for all eventualities of disaster within their jurisdictions as mandated by the RA 7160 or the Local Government Code and RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010; to update, revisit, reassess, recalibrate their MDRRM plans and also to update their ordering agreements or acceptance/acquisition of the relief goods in order to assess their preparedness to handle and mitigate the effects of natural disasters amidst the COVID-19 Pandemic.


RECOMMENDATIONS:


