SUBJECT: Result of the Public Hearing on the Proposed Municipal Ordinance No. 2020-005 – “2020 Revised Code of General Ordinances of the Municipality of Tigbauan”

The following important comments/opinions/views, suggestions, queries were noted down during the lengthy discussions on Draft Municipal Ordinance No. 2020-005:

As a backgrounder, the Vice Mayor as *Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters* enlightened the participants on the following:

- (a) the previous mandatory Codes which were already passed by this August Body, in which public hearings were also conducted with the participation of the Punong Barangays of this municipality and/or their representatives as well as the concerned stakeholders.
- (b) the “**codification process**”, which is the gathering and compiling (*based on the subject matter*) of all previous and existing municipal ordinances in just one Code; that this codification process includes the process of supplementation, insertion of new provisions in the code, or amendment/correction, revision of existing municipal ordinances or just the provisions thereof, if necessary;

- (c) that since the existing Code of General Ordinances was passed back in 2014, it needs to be revised/updated so as to include municipal ordinances enacted from 2014 onwards which shall be included in this proposed 2020 revision of the Code of General Ordinances, to wit:

The Vice Mayor further informed the participants that an additional provision in the Code pertaining to the regulation on the use of hanging bridges and overflows shall be provided; that violation of the load limit shall be considered as unlawful and punishable.

The participants were also advised to freely approach the committee chairmen concerned in case they have other suggestions pertaining to their respective chairmanships for inclusion in the proposed revision of the Code.

RECOMMENDATIONS:

1. To make the necessary corrections/amendments in the said draft ordinance;
2. To attach the minutes of the Public Hearing on November 27, 2020 as an integral part of this committee report;
3. To adopt this Committee Report; and
4. To calendar for 2nd reading Draft Municipal Ordinance No. 2020-005 – “2020 Revised Code of General Ordinances of the Municipality of Tigbauan”

The Committee further recommends for the adoption of this Committee Report.


