APPROPRIATION ORDINANCE NO. 2003-001
SUPPLEMENTAL BUDGET NO. 2003-001

AN ORDINANCE APPROPRIATING AND SUPPLEMENTING THE AMOUNT OF TWO HUNDRED SIXTY SIX THOUSAND FOUR HUNDRED PESOS (P266,400.00) FOR THE PAYMENT OF THE FULL IMPLEMENTATION OF REPRESENTATION AND TRANSPORTATION ALLOWANCE (RATA) OF ALL MUNICIPAL OFFICIALS, DEPARTMENT HEADS AND ASSISTANT DEPARTMENT HEADS OF THE MUNICIPALITY EFFECTIVE JANUARY 1 TO DECEMBER 31, 2003.

WHEREAS, Section 41 of the GAA CY 2000 provides for the standardization of Representation and Transportation allowance (RATA) of all Municipal Officials, Department Heads and their assistants;

WHEREAS, as recommended by the Municipal Accountant, the total supplemental appropriation in the amount of Two Hundred Sixty Six Thousand Four Hundred Pesos (P266,400.00) for the payment of the full implementation of Representation And Transportation Allowance (RATA) of all Municipal Officials, Department Heads and Assistant Department Heads of the Municipality effective January 1 to December 31, 2003.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, ILOILO, that:

SECTION 1. - The total amount of Two Hundred Sixty Six Thousand Four Hundred (P266,400.00) Pesos be appropriated for the payment of the full implementation of Representation and Transportation Allowance (RATA) of all Municipal Officials, Department Heads and Assistant Department Heads of the Municipality effective January 1 to December 31, 2003.


SECTION 2. - Such appropriation and supplemental budget shall be charged against the salary savings of the Municipal Budget Officer and Municipal Treasurer from January 1 to May 31, 2003 and salary savings of Community Affairs Officer III from January 1 to April 30, 2003.

SECTION 3. - This Appropriation Ordinance and Supplemental Budget shall take effect upon approval.


