WHEREAS, as the year end come to a close, several employees of the Municipal
Government has signified their intention to retire from service;

WHEREAS, retirees need to avail of terminal pay as compensation for the services they
have rendered to the municipality;

WHEREAS, Terminal pay for government employees and officials is subject to
availability of funds in the government unit;

WHEREAS, the Municipal Budget Officer has certified that there is a Surplus/ Savings
for CY 2005 in the amount of Nine Hundred Thousand Four Hundred Twenty Five Pesos and
42/100 (P900,425.42),

WHEREAS, this Surplus Savings could be appropriated to supplement the terminal pay of local government officials and employees who have signified their intention to retire from service,


NOW, THEREFORE, Be It Ordained By The Sangguniang Bayan of Tigbauan, Iloilo That: An Appropriation & Supplemental Budget of Nine Hundred Thousand Four Hundred Twenty Five and 42/100 (P900,425.42) Pesos Be Enacted Chargeable Against The Surplus/Savings of CY 2005 As Certified By The Municipal Budget Office.

This Appropriation Ordinance and Supplemental Budget shall take effect upon approval.


ENACTED. September 4, 2006.


