Appropriation Ordinance No. 2008 – 001  
Supplemental Budget No. 2008 – 001

AN ORDINANCE APPROPRIATING AND SUPPLEMENTING THE AMOUNT OF TWO MILLION TWO HUNDRED FIFTY ONE THOUSAND ONE HUNDRED FORTY EIGHT PESOS (P2,251,148.00) ONLY FOR THE PAYMENT OF THE FOLLOWING EXPENDITURES: MONETIZATION/TERMINAL LEAVE BENEFITS; TRAINING/SEMINAR EXPENSES (COMPETENCY ENHANCEMENT TRAINING & INTERFACE WITH THE LOCAL OFFICIALS OF TOP PERFORMING LGUs; TRAVELLING EXPENSES FOR THE OFFICE OF THE SANGGUNIANG BAYAN; AND PROCUREMENT OF OFFICE EQUIPMENT (DIGITAL CAMERA) FOR THE MUNICIPAL ENGINEER'S OFFICE AND EXECUTIVE CHAIRS FOR S.B. SESSION HALL, LGU-TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Hon. Mayor James Excelsior M. Torres (thru his 1st Indorsement dated March 14, 2006) requested for the passing of an Appropriation Ordinance for a Supplemental Budget for the payment of the following expenditures: Monetization/Terminal Leave Benefits; Training/Seminar Expenses (Competency Enhancement Training & Interface with Local Officials of Top Performing LGUs); Travelling Expenses for the Office of the Sangguniang

Bayan; and Procurement of Office Equipment(Digital Camera) for the Municipal Engineer's Office and Executive Chairs for S.B. Session Hall, LGU-Tigbauan;

WHEREAS, the Local Government Unit of Tigbauan has **Unprogrammed Surplus/Savings - CY 2007 in the amount of P2,251,148.00** per certified statement of savings/surplus as of December 31, 2007 duly signed by the OIC-Municipal Accountant, Mrs. Salvacion Trayfalgar and the OIC-Municipal Treasurer, Mr. Edwin Pirote, attached as ANNEX "A" and forms as an integral part of this Appropriation Ordinance;

WHEREAS, Section 22 and 23 of the Omnibus Rules on Leave, Rule XVI of the Omnibus Rules Implementing Book V of E.O. 292 provides for the privilege of monetization of vacation leave credits to employees and officials in the career and non-career service;

WHEREAS, the granting of monetization/terminal leave benefits to local government employees and officials is subject to the availability of funds in the Local Government Unit;

WHEREAS, considering the high cost of services and commodities, it is necessary to supplement also the travel expenses budget of the S.B. Office;

WHEREAS, Rule VIII (Career & Personnel Development) of the CSC Omnibus Rules states that every official and employee of the government is an asset or resource to be valued, developed and utilized in the delivery of basic services to the public, hence, the development and retention of a highly competent and professional workforce in the public service shall be the main concern of every agency. For this reason, LGU-Tigbauan will conduct training/seminar (Competency/Enhancement Training & Interface with the Local Officials of Top Performing LGUs). Attached as ANNEX "B" is the design for said activity duly approved by Hon. Mayor James Excelsior M. Torres, and shall likewise form as an integral part of this Appropriation Ordinance;

WHEREAS, the Engineering Department badly needs office equipment (Digital Camera) for office use especially for project documentation;

WHEREAS, the Sangguniang Bayan is in need of Executive Chairs for use in the Session Hall;

WHEREAS, the Supplemental Budget on Funds Actually Available (consisting of two pages) is hereto attached as ANNEX "C" and also forming as an integral part of this Appropriation Ordinance;

NOW, THEREFORE, upon motion of Hon. Marlon R. Teruñez, Vice Chairman, Committee on Appropriation, Budget, Finance, Accounts and Ways & Means and under the Sponsorship of Hon. Suzette Marie Hilado-Banno, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, that:

SECTION 1. - The total amount of Two Million Two Hundred Fifty One Thousand One Hundred Forty Eight Pesos (P2,251,148.00) only is hereby appropriated for payment of the following expenditures: Personal Services, MOOE and Capital Outlay, LGU-Tigbauan, Province of Iloilo:

Personal Services	-----	P1, 240,147.22
MOOE	-----	951,000.00
Capital Outlay	-----	60,000.78
<b>Total</b>	-----	<b>P 2, 251,148.00</b>

SECTION 2. - Such appropriation and supplemental budget shall be charged against the total surplus/savings as of December 31, 2007 duly certified by the OIC-Municipal Accountant and the OIC-Municipal Treasurer.




