AN ORDINANCE APPROPRIATING AND SUPPLEMENTING THE AMOUNT OF ONE MILLION THREE HUNDRED NINETY NINE THOUSAND PESOS ONLY (P1,399,000.00) FOR THE PAYMENT OF PERSONAL SERVICES EXPENDITURES OF DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO CHARGEABLE AGAINST THE UNPROGRAMMED SURPLUS/SAVINGS - CY 2008

WHEREAS, the Municipal Mayor requested for the passing of an Appropriation Ordinance for a supplemental budget chargeable against the unprogrammed surplus/savings of CY 2008;

WHEREAS, the Local Government Unit of Tigbauan has unprogrammed surplus savings – CY 2008 per certified statement of savings as of CY 2008 (*hereto attached as Annex "A"*) in the amount of One Million Three Hundred Ninety Nine Thousand Pesos (P1,399,000.00) duly signed by the OIC Municipal Accountant – Mrs. Salvacion T. Trayfalgar and the OIC Municipal Treasurer – Mr. Edwin L. Pirote;

WHEREAS, there is a need to supplement funds for the payment of Personal Services Expenditures for the following:

- a.) Terminal Leave Pay for three (3) Regular Employees for the Office of the Mayor, Agriculture and Engineering and Underestimated Terminal Pay Budget in the Office of the Sangguniang Bayan
- b.) Underestimated Budget for Hazard Pay, Life/Ret. Insurance Premium and PhilHealth in the Municipal Health Office



c.) Underestimated Budget for Life Insurance Premium in the Municipal Budget and Municipal Treasurer's Office

d.) Monetization Leave Benefits for ten (10) days of Municipal Officials and Employees of the Different Offices of LGU-Tigbauan

NOW, THEREFORE BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, ILOILO THAT:

**Section 1.** The total amount of One Million Three Hundred Ninety Nine Thousand (P1,399,000.00) Pesos is hereby appropriated for the following:

Terminal Leave for three (3) Regular  
Employees for the Office of the Mayor,  
Agriculture and Engineering and Underestimated  
Terminal Pay Budget in the Office of the Sangguniang  
Bayan ----- P 521,378.24

Underestimated Budget for Hazard Pay, Life/Ret.  
Insurance Premium and PhilHealth in the  
Municipal Health Office ----- 21,079.00

Underestimated Budget for Life Insurance Premium  
in the Municipal Budget and Municipal Treasurer's Office --- 7,119.00

Monetization Leave Benefits for ten (10) days of  
Municipal Officials and Employees of the Different  
Offices of LGU-Tigbauan ----- 849,423.76

**TOTAL SUPPLEMENTAL APPROPRIATION----- P1,399,000.00**



Pirote;

**Section 3.** The appropriated amounts as embodied in this Appropriation Ordinance and Supplemental Budget shall be subject to usual accounting and auditing rules and procedures and other applicable laws.


**Section 4.** This Appropriation Ordinance and Supplemental Budget shall take effect upon approval.


