WHEREAS, for the CY 2008, there is an unprogrammed surplus/savings in the amount OF EIGHT MILLION EIGHT HUNDRED NINETY ONE THOUSAND THREE HUNDRED FIFTY EIGHT AND 1/100 (P8,891,358.01) as certified by the OIC-Municipal Accountant, Mrs. Salvacion Trayfalgar and the OIC-Municipal Treasurer, Mr. Edwin Pirote, hereto attached as an integral part of this Appropriation Ordinance as ANNEX "A";

WHEREAS, the Municipal Mayor requested for supplemental budget to augment funds for the fiscal year 2009;

WHEREAS, the supplemental budget on Funds Actually Available for FY 2009 prepared by Mrs. Pacita Ledesma, Municipal Budget Officer and approved by Hon. Mayor James Excelsior M. Torres is likewise attached as an integral part of this Appropriation Ordinance as

WHEREAS, Section 22 and 23 of the Omnibus Rules on Leave, Rule XVI of the Omnibus Rules Implementing Book V of Executive order 292 provides for the privilege of

monetization of vacation leave credits to employees and officials in the career and non-career service;

WHEREAS, the granting of monetization/Terminal Pay to local government employees and officials is subject to the availability of funds in the Local Government Unit;

WHEREAS, it is also necessary to supplement funds (under the MOOE) for the purchase of additional medicines and vaccines for Municipal Health Office, additional funding for Mayor's Office for security services, repair and maintenance – IT Equipment (Rehabilitation of IT-Equipment, Updating and Programming) and other maintenance and operating expenses (Sports Activities Expenses);

WHEREAS, for the delivery of efficient and effective service to the constituents it is likewise necessary to supplement funds (under the Capital Outlay) for the Mayor's Office for the purchase of IT-Equipment & Software (Two (2) Computer Sets with Printer), and One (1) unit heavy equipment (Dumptruck), and for the Municipal Agriculture Office, two (2) units Four-Wheel Drive Tractors for agricultural enhancement;

WHEREAS, a COMMITTEE REPORT NO. 2009-011, was adopted on February 25, 2009 and will form part of this ordinance;

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:
