Appropriation Ordinance No. 2009-003
Supplemental Budget No. 2009-002

AN ORDINANCE APPROPRIATING AND SUPPLEMENTING THE AMOUNT OF SIX HUNDRED FORTY-ONE THOUSAND FOUR HUNDRED SEVENTY THREE PESOS (P641,473.00) FOR THE PAYMENT OF THE TRAINING/SEMINAR EXPENSES OF THE ELECTED MUNICIPAL OFFICIALS, DEPARTMENT HEADS AND OTHER PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO CHARGEABLE AGAINST THE UNPROGRAMMED SURPLUS/SAVINGS - CY 2008

WHEREAS, the enactment of RA 9485 or the Anti-Red Tape Act of 2007 (AN ACT TO IMPROVE EFFICIENCY IN THE DELIVERY OF GOVERNMENT SERVICE TO THE PUBLIC BY REDUCING BUREAUCRATIC RED TAPE PREVENTING GRAFT AND CORRUPTION, AND PROVIDING PENALTIES THEREFOR), tasks the Civil Service Commission (CSC), Office of the Ombudsman (OBM), Presidential Anti-Graft Commission (PAGC) and the Development Academy of the Philippines (DAP) to ensure the effective implementation of the above cited Act. They are also tasked to promulgate the necessary implementing rules and regulations;

WHEREAS, the law in its lines specifically Sec. 6 speaks of the Citizen's Charter and demands for all government agencies including departments, bureaus, offices,

instrumentalities, or government-owned and/or controlled corporations, or local government or district units to set up their respective service standards to be known as the Citizen's Charter in the form of information billboards which should be posted at the main entrance of offices or at the most conspicuous place, and in the form of published materials written either in English, Filipino, or in local dialect, that details a.) Procedure to obtain a particular service b.) Person/s responsible for each step c.) Maximum time to conclude the process d.) Document/s to be presented by the customer, if necessary e.) Amount of fees, if necessary and f.) procedure for filing complaints;

WHEREAS, the Department of Interior and Local Government (DILG) through its Local Government Academy (LGA) has spearheaded an anti-red tape advocacy program dubbed as Project CURE which stands for Comprehensive and Unified Response to Eliminate Red-Tape in LGUs;

WHEREAS, the Local Government of Tigbauan in support to this campaign wants to promote transparency in government with regard to the manner of transacting with the public by requiring each agency to simplify frontline service procedures, formulate service standards to be observed in every transaction and make known these standards to the client;

WHEREAS, the Municipal Mayor (thru 1st Indorsement dated June 2, 2009) requested for the passing of an Appropriation Ordinance for a supplemental budget for the crafting of Citizen's Charter for the Municipality of Tigbauan, Province of Iloilo as mandated by RA 9485 chargeable against the unprogrammed surplus/savings as of CY 2008;

WHEREAS, the Local Government Unit of Tigbauan has unprogrammed surplus savings - CY 2008 per Certified Statement of Savings/Surplus as of CY 2008 (hereto attached as Annex "A") in the amount of Six Hundred Forty-One Thousand Four Hundred Seventy Three Pesos (P641,473.00) duly signed by the OIC Municipal Accountant - Mrs. Salvacion T. Trayfalgar and the OIC Municipal Treasurer - Mr. Edwin L. Pirote;

WHEREAS, the supplemental budget of Funds Actually Available for FY 2009 prepared by Mrs. Pacita Ledesma, Municipal Budget Officer and approved by Hon. Mayor James Excelsior M. Torres is likewise attached as an integral part of this Appropriation Ordinance as ANNEX "B";

WHEREAS, there is a need to supplement funds for the payment of the Training/Seminar Expenses of the Elected Municipal Officials, Department Heads and Other Personnel of the Local Government Unit Of Tigbauan for the crafting of Citizen's Charter;

NOW, THEREFORE BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, THAT:

Section 1. The total amount of Six Hundred Forty-One Thousand Four Hundred Seventy Three Pesos (P641,473.00) is hereby appropriated for the Training/Seminar Expenses of the Elected Municipal Officials, Department Heads and Other Personnel of the Local Government Unit Of Tigbauan (as listed in the attached training design).

Section 2. Such appropriation ordinance and supplemental budget shall be charged against the Unprogrammed Surplus/Savings - CY 2008 of the Municipality of Tigbauan as per Certified Statement of Savings/Surplus as of CY 2008 duly signed by



Section 3. The appropriated amounts as embodied in this Appropriation Ordinance and Supplemental Budget shall be subject to usual accounting and auditing rules and procedures and other applicable laws.


Section 4. This Appropriation Ordinance and Supplemental Budget shall take effect upon approval.
