**Appropriation Ordinance No. 2009-005
Supplemental Budget No. 2009-004**

AN ORDINANCE APPROPRIATING AND SUPPLEMENTING THE AMOUNT OF ONE
MILLION PESOS (P1,000,000.00) FOR THE PROCUREMENT OF FARM
IMPLEMENTS FOR THE USE OF THE FARMERS OF THE MUNICIPALITY OF
TIGBAUAN, PROVINCE OF ILOILO, CHARGEABLE AGAINST THE
UNDERESTIMATED IRA SHARE – CY 2009

WHEREAS, for the CY 2009, there is an underestimated IRA Share in the
amount of Nine Million Twenty Eight Thousand Forty One Pesos (P9,028,041.00), 20%
of which in the amount of P1,805,608.20 was allocated to development projects and the
5% to calamity fund amounting to P451,402.05 with the total amount of P2,257,010.25.
This resulted to an additional realized income of P6,771,030.75. Copy of the Certified
Statement of Additional Realized Income as of CY 2009 duly signed by Edwin L. Pirote,
OIC-Municipal Treasurer, is hereto attached as an integral part of this Appropriation
Ordinance as ANNEX "A";

WHEREAS, the Municipal Mayor requested for a supplemental budget for the
proposed plans, programs and projects, this municipality, which includes the
procurement of farm implements amounting to P1,000,000.00. However, when the
needed appropriation ordinance was enacted on August 6, 2009, the said item was not
included or deferred for the succeeding and separate supplemental budget until the
same had been further clarified by the August Body during the presence of the
Municipal Agriculturist, Mrs. Eugenia T. Sayson, on the SB's next regular session.

WHEREAS, the Supplemental Budget on funds actually available for FY 2009 duly approved by the Municipal Mayor, Hon. James Excelsior M. Torres, is likewise attached as integral part of this Appropriation Ordinance as ANNEX "B";

WHEREAS, after a thorough deliberation on the matter and there being no more questions and clarifications raised on the Floor, the August Body eventually passed the Appropriation Ordinance/Supplemental Budget for the procurement of farm implements in the amount of P1,000,000.00.

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:

Section 1. The amount of P1,000,000.00 is hereby appropriated for the procurement of farm implements which are badly needed to enhance agricultural production as well as to help the small farmers.


Section 2. Such Appropriation Ordinance and Supplemental Budget shall be charged against the underestimated IRA Share CY - 2009 duly certified by the OIC-Municipal Treasurer.

Section 3. The appropriated amount as embodied in the Supplemental Budget and Appropriation Ordinance shall be used for the procurement of farm implements and disbursement of funds relative thereto shall be subject to usual accounting and auditing rules and procedures and other applicable laws.


Section 4. This Appropriation Ordinance and Supplemental Budget shall take effect upon approval.


