- a. The appropriation for 20% development fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;
- b. An appropriation of P1,020,000.00 under the Executive Services shall be for community direct action program under the direction of the Local Chief Executive, while the amount of P600,000.00 under the Legislative Services shall be for community direct action program for the development projects of the fifty two (52) barangays under the direction of the Sangguniang Bayan Members and the Vice Mayor wherein they have their respective areas of jurisdiction;
- c. Disbursement of the 20% development fund shall be made strictly pursuant to Joint Memorandum Circular No. 1 series of 2005 by DILG and DBM and Memorandum Circular No. 210-138 of the DILG dated December 2, 2010;
- d. Compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government units and the local chief executive.

Section 4. The execution of the Budget for FY 2011 of the Municipality of Tigbauan shall comply with the budgetary requirements and limitation in the Local Government Code and its Implementing Rules and Regulations.

Section 5. The vacant positions and created positions shall not be funded unless an appropriate Sangguniang Bayan Appropriation Ordinance is passed and until such time that the personal services limitation as provided for in the Local Government Code shall be complied with.

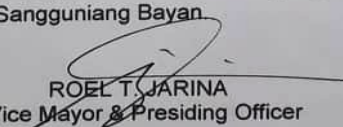
Section 6. Any change in the Annual Budget for FY 2011 of the Municipality of Tigbauan shall be made in accordance with the provision of Section 321 and 336 of the Local Government Code.

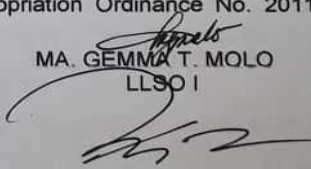
Section 7. This Appropriation Ordinance shall take effect immediately upon approval.
