



AN ORDINANCE APPROPRIATING AND AUGMENTING THE AMOUNT OF ONE
HUNDRED TWENTY SEVEN THOUSAND (P127,000.00) FOR THE PAYMENT OF CY
2012 UNDERESTIMATED BUDGET FOR CLOTHING ALLOWANCE OF MUNICIPAL
OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF
TIGBAUAN CHARGEABLE AGAINST THE SALARY SAVINGS OF THE OFFICE OF
THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC) FROM
JANUARY TO APRIL 2012.

WHEREAS, Budget Circular No. 2012-1 dated February 23, 2012 of the
Department of Budget and Management provides for the guidelines on the grant of
uniform or clothing allowance of employees at not more than P5,000 per annum, subject
to the rules and regulations issued by the DBM;

WHEREAS, the Local Government Unit of Tigbauan had released last January of
this year the amount of Four Thousand Pesos (P4,000.00) per personnel for clothing
allowance which fall short of the allowable allowance by the DBM;

WHEREAS, 127 personnel, both permanent, appointive and elective officials are
entitled to the benefits of additional clothing allowance;

WHEREAS, there is an available amount of One Hundred Twenty Seven
Thousand Pesos from Salary Savings of the MPDO, Salary Grade 24-8, as per
Certification of the Municipal Budget Officer, OIC Municipal Accountant and OIC
Municipal Treasurer;

WHEREAS, there is a need to augment the funds for the payment of additional Clothing Allowance to Government Officials and Employees of the Local Government Unit of Tigbauan for Fiscal Year 2012;

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:

Section 1. The total amount of P127,000.00 is hereby augmented for the payment of Additional Clothing Allowance to Government Personnel of the Local Government Unit of Tigbauan for Fiscal Year 2012, in the amount of One Hundred Twenty Seven Thousand Pesos (P127,000.00) at P1,000.00 each.


Section 2. Such Appropriation Ordinance and Supplemental Budget shall be charged against the savings from Personal Services for the CY 2012, salary savings of the Municipal Planning and Development Coordinator from January to April 2012;

Section 3. The appropriated amount as embodied in this Appropriation Ordinance shall be used solely for the purpose of the payment of Additional Clothing Allowance to Government Personnel of the Local Government Unit of Tigbauan for Fiscal Year 2012, subject to the provisions in Budget Circular No. 2012-1 dated February 23, 2012 issued by the DBM. Disbursements of funds relative thereto shall be subject to usual accounting and auditing rules and procedures and other applicable laws.


Section 4. This Appropriation Ordinance and Augmentation of fund shall take effect upon approval.
