AN ORDINANCE AUGMENTING THE AMOUNT OF THREE MILLION ONE HUNDRED THIRTY THOUSAND SIX HUNDRED EIGHT PESOS (P3,130,608.00) FOR THE PAYMENT OF CY 2012 PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) OF MUNICIPAL OFFICIALS AND EMPLOYEES OF LGU-TIGBAUAN PER DBM CIRCULAR NO. 2012-3 DATED NOVEMBER 29, 2012, TERMINAL LEAVE BENEFITS OF EXECUTIVE ASSISTANT, OFFICE OF THE MAYOR AND FOR PAYMENT OF VARIOUS NECESSARY MOOE, OFFICE OF THE MAYOR CHARGEABLE AGAINST CY 2012 TOTAL P.S. SAVINGS AND FROM THE UNEXPENDED BALANCES OF MOOE, OFFICE OF THE MAYOR, RESPECTIVELY.

WHEREAS, Budget Circular No. 2012-3 dated November 29, 2012 of the Department of Budget and Management provides for the guidelines on the grant of PEI to employees at rates to be determined by the respective sanggunian, depending on the LGU financial capability, and subject to the rules and regulations issued by the DBM;

WHEREAS, 125 personnel, both permanent, appointive and elective officials are entitled to the PEI benefits;

WHEREAS, there is an available amount of Three Million One Hundred Thirty Thousand Six Hundred Eight Pesos (P3,130,608.00) from the Total P.S. Savings And

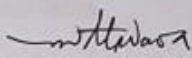

SECTION 4. The appropriated amounts as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditures of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

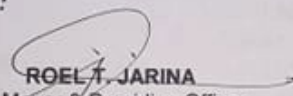
Section 5. This Appropriation Ordinance and Augmentation of fund shall take effect upon approval.
