Appropriation Ordinance No. 2012-006

AN ORDINANCE AUGMENTING THE AMOUNT OF ONE MILLION TWO HUNDRED EIGHTY FIVE THOUSAND PESOS (P1,285,000.00) FOR THE PAYMENT OF CY 2012 PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) OF MUNICIPAL OFFICIALS AND EMPLOYEES OF LGU-TIGBAUAN PER DBM CIRCULAR NO. 2012-03 DATED NOVEMBER 29, 2012, CHARGEABLE AGAINST TOTAL PERSONAL SERVICES (PS) SAVINGS -TERMINAL BENEFITS PER SUPPLEMENTAL BUDGET NO. 2012-03, APPROPRIATION ORDINANCE NO. 2012-04

WHEREAS, Budget Circular No. 2012-03 dated November 29, 2012 of the Department of Budget and Management provides for the guidelines on the grant of PEI to employees at rates to be determined by the respective sanggunian, depending on the LGU financial capability, and subject to the rules and regulations issued by the DBM:

WHEREAS, 125 personnel, both permanent, appointive and elective officials are entitled to the PEI benefits;

WHEREAS, there is an available amount of One Million Two Hundred Eighty Five housand Pesos (P1,285,000.00) For The Payment Of CY 2012 Productivity Enhancement Phousand Pesos (F1,200,300) and Employees Of LGU-Tigbauan Per DBM Circular No. Incentive (PEI) Of Municipal Circular No. 2012-03 Dated November 29, 2012, Chargeable Against Total Personal Services (PS) Savings 2012-03 Dated November 2012-03 Dated November 2012-03 Dated November 2012-03 Dated November 2012-04 Dated November 2012-04 Dated November 2012-04 Dated November 2012-05 Dated November 04 per Centification of the Accountant) and Noted by the Municipal MPDO, Municipal Budget Officer, OIC Municipal Accountant) and Noted by the Municipal

WHEREAS, there is a need to augment the funds for the payment of CY 2012 Productivity Enhancement Incentive (PEI) Of Government Officials And Employees of the Local Government Unit of Tigbauan for Fiscal Year 2012, Chargeable Against Total Personal Services (PS) Savings — Terminal Benefits Per Supplemental Budget No. 2012-03, Appropriation Ordinance No. 2012-04:

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:

Section 1. The total amount of P1,285,000.00 is hereby augmented for the payment of CY 2012 Productivity Enhancement Incentive (PEI) of the Government Personnel of the Local Government Unit of Tigbauan for Fiscal Year 2012, Chargeable Against Total Personal Services (Ps) Savings — Terminal Benefits Per Supplemental Budget No. 2012-03, Appropriation Ordinance No. 2012-04 in the amount of One Million Two Hundred Eighty Five Thousand Pesos (P1,285,000.00), copy of the Certification issued by the Local Finance Committee dated December 19, 2012 duly noted by the Municipal Mayor is hereto attached as Annex "A", forming part of this Appropriation Ordinance.

Section 2. This Appropriation Ordinance and augmentation of funds, the source of which is from the Total P.S. Savings – Terminal Benefits Per Supplemental Budget No. 2012-03, Appropriation Ordinance No. 2012-04:

Section 3. The appropriated amount as embodied in this Appropriation Ordinance shall be used solely for the purpose of the payment of CY 2012 Productivity Enhancement Incentive (PEI) Of Municipal Officials And Employees Of LGU-Tigbauan for Fiscal Year 2012, subject to the provisions in Budget Circular No. 2012-1 dated February 23, 2012 issued by the DBM. Disbursements of funds relative thereto shall be subject to usual accounting and auditing rules and procedures and other applicable laws. Statement of Appropriation for Augmentation as prepared for by the Municipal Budget Officer and the Municipal Mayor is hereto attached as Annex "B" forming part of this Appropriation Ordinance.

Section 4. The appropriated amounts as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and regulations. Compliance with existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditures of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

Section 5. This Appropriation Ordinance and Augmentation of fund shall take effect upon approval.
