AN ORDINANCE APPROPRIATING FOR A SUPPLEMENTAL BUDGET IN THE AMOUNT OF FOUR MILLION ONE HUNDRED FIFTY THOUSAND PESOS (P4,150,000.00) FOR TERMINAL LEAVE BENEFITS / MONETIZATION OF LEAVE CREDITS IN THE AMOUNT OF ONE MILLION NINE HUNDRED SEVENTY FIVE THOUSAND PESOS (P1,975,000.00), FOR MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE MAYOR'S OFFICE AND SB OFFICE IN THE AMOUNT OF TWO MILLION ONE HUNDRED TWENTY FIVE THOUSAND PESOS (2,125,000.00), AND FOR PROCUREMENT OF OFFICE EQUIPMENT OF THE TREASURER'S OFFICE IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) CHARGEABLE AGAINST THE CY 2012 NET SURPLUS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

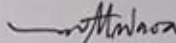

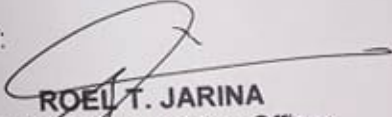
SECTION 5. EFFECTIVITY. The provisions of this Ordinance shall take effect upon its approval.
