Compliance with all existing laws, nd regulations shall be the responsibility of the officials authorizing the disbursement of Expenditure of funds in violation of the Local Government Code and other laws shall be a hal liability of the official or employee responsible therefore.

ection 19. Any change in the Annual Budget for FY 2014 of the Municipality of Tigbauan shall ade in accordance with the provisions of Section 321 and 336 of the Local Government Code.

Section 20. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance eclared invalid or unconstitutional, other sections or provisions thereof which are not affected reby shall continue to be in full force and effect.

Section 21. EFFECTVITY. This Appropriation Ordinance shall take effect January 1, 2014.
