



WHEREAS, the total amount of P 105,220,343.00 has been appropriated for the delivery of
basic services, priority programs, activities for the promotion of general welfare of the municipality
and its inhabitants,

WHEREAS, the budget embodies estimated income receipts for FY 2014 are as follows:

Local Sources	4,611,000.00

WHEREAS, proposed expenditures for FY 2014 are as follows:

Other Purposes (Loan Amortization)	2,000,000.00
Special Account in the General Fund	10,413,764.00
Total	P 105,220,343.00

WHEREAS, series of Budget Hearings were conducted by the Committee on Appropriations
and the proposed Executive Annual Budget for 2014 as well as the Annual Investment Plan for 2014
were thoroughly discussed together with the members of the Local Finance Committee, the
department heads and other responsible local officials;

Section 18. The appropriated amounts as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditure of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

Section 19. Any change in the Annual Budget for FY 2014 of the Municipality of Tigbauan shall be made in accordance with the provisions of Section 321 and 336 of the Local Government Code.


Section 20. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected hereby shall continue to be in full force and effect.

Section 21. EFFECTIVITY. This Appropriation Ordinance shall take effect January 1, 2014.


