

1. APPROPRIATION ORDINANCE NO. 2015-002 - AN ORDINANCE FOR THE AUGMENTATION OF FUNDS AMOUNTING TO TWO MILLION ONE HUNDRED EIGHTY SIX THOUSAND FOUR HUNDRED FIFTY PESOS (P2,186,450.00) FROM PERSONAL SERVICES SAVINGS FROM JANUARY 1, TO JUNE 30, 2015 FOR THE PAYMENT OF FY 2015 PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) OF OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN PURSUANT TO EXECUTIVE ORDER NO. 181 OF THE OFFICE OF THE PRESIDENT.

NOW THEREFORE, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, the following Appropriation Ordinance:

Section 1. The amount of P 2,186,450.00 from savings in Personal Services of FY 2015 from January 1 to June 30, 2015 is hereby augmented for the payment of Productivity Enhancement Incentive (PEI) of the officials and employees of the Local Government Unit of Tigbauan pursuant to Executive Order No. 181 of the President of the Philippines;

Section 2. Pertinent provisions of the Local Government Code and its implementing rules and regulations applicable to the augmentation of funds from savings in the other items within the same class of expenditures shall be accordingly complied with;

Section 3. Augmentation of funds from savings in the Personal Services of FY 2015 from January 1 to June 30, 2015 for the payment of FY 2015 PEI as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures.

Section 4. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

Section 5. **EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon the approval thereof.

RESOLVED FURTHER, to forward copies of this Appropriation Ordinance to the Office of the Municipal Mayor, Provincial Budget Officer, Sangguniang Panlalawigan, Department of Budget and Management, Region VI, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Office, the Municipal Accountant and to all concerned for their information and appropriate action.
