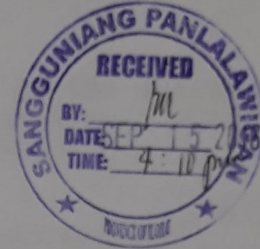

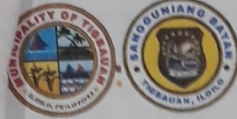

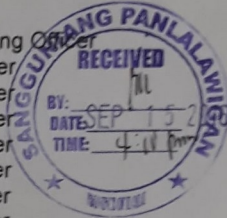

Appropriation Ordinance No. 2016-004

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO AUGMENT FUNDS TO MAYOR'S OFFICE - NON-OFFICE - PNP ADVISORY COUNCIL - OTHER MOOE TO BE TAKEN FROM CY 2016 ANNUAL BUDGET OF MAYOR'S OFFICE - REPAIR/MAINTENANCE OF OFFICE BUILDING/PLAZA IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00).

WHEREAS, the Municipal Anti-Drug Abuse Council has recently submitted the proposal for the Anti Drug Abuse and other Anti-Criminality programs and activities in the Municipality of Tigbauan for the remaining months of this year, 2016 with a budget of P200,000.00;

WHEREAS, due to a limited budget intended for Mayor's Office - Non-Office - PNP Advisory Council - Other MOOE, the amount of P200,000.00 is needed for the implementation of the above-mentioned programs of the municipality to be taken from the CY 2016 Annual Budget of Mayor's Office - Repair/Maintenance of Office Building/Plaza for the augmentation thereof;

WHEREAS, in full support of the present administration's intensive campaign against illegal drugs which poses as a serious detriment to society and the welfare of the people, the LGU considers anti drug abuse programs as among its priorities;

WHEREAS, the prompt and continuous delivery of basic services to the populace is of paramount concern and responsibility of the local government unit and entails the utilization of funds as appropriated in the approved annual budget;

WHEREAS, Section 336 of the Local Government Code (LGC) expressly provides that Funds shall be available exclusively for the specific purpose for which they have been appropriated and prohibits the transfer of appropriations from one item to another;

WHEREAS, said Section 336 of the LGC however, provides an exception to the above-mentioned general rule, to wit,

"...the Local Chief Executive or the Presiding Officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget of their respective offices from savings in other items within the same expense class of their respective appropriations".

WHEREAS, the Local Chief Executive, in a letter to the Sangguniang Bayan dated September 5, 2016 identified the need to augment certain items in the 2016 budget of the Executive Department from savings thereon within the same expense class;

WHEREAS, a certification has been issued by Mrs. Salvacion T. Trayfalgar, *OIC-Municipal Accountant* and Mrs. Pacita T. Ledesma, *Municipal Budget Officer* that the amount of P200,000.00 from the appropriated amount for the Mayor's Office- *Repair/Maintenance of Office Building/Plaza* CY 2016 Annual Budget is available to be augmented to Mayor's Office -*Non-Office – PNP Advisory Council – Other MOOE* since they are under the same classification as MOOE;

WHEREAS, to accordingly address the needs of the local government unit for the effective and efficient delivery of its functions and for un-programmed activities, the grant of authority to the Local Chief Executive to augment any item in the approved annual budget from savings in other items within the same expense class, pursuant to said Section 336 of the LGC, is deemed beneficial to and would enhance public service;

WHEREFORE, BE IT ENACTED by the Sangguniang Bayan that:


- Section 1.** Authority is hereby granted to Atty. Suzette Tenefrancia-Alquisada, Local Chief Executive, to augment funds to Mayor's Office – *Non-Office – PNP Advisory Council – Other MOOE* to be taken from CY 2016 Annual Budget of Mayor's Office- *Repair/Maintenance of Office Building/Plaza* in the Amount of Two Hundred Thousand Pesos (P200,000.00);
- Section 2.** Pertinent provisions of the Local Government Code and its implementing rules and regulations applicable to the authority herein granted shall be accordingly complied with;
- Section 3.** Augmentation of budget items from any savings within the same expense class and the utilization of funds related thereto as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures;
- Section 4.** Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore;
- Section 5.** EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon the approval thereof.


