**Appropriation Ordinance No. 2017-001

AN ORDINANCE APPROPRIATING FOR A SUPPLEMENTAL BUDGET FOR FISCAL YEAR 2017 THE AMOUNT OF FOUR MILLION TWO HUNDRED SIXTY-SIX THOUSAND TWELVE PESOS AND FIFTY-SEVEN CENTAVOS (P 4,266,012.57) FOR **MOOE** OF THE FOLLOWING: MAYOR'S OFFICE IN THE AMOUNT OF P700,000.00 (*TOURISM PROGRAMS-PAGDAUG SALUDAN FESTIVAL 2017*), SANGGUNIAN BAYAN OFFICE IN THE AMOUNT OF P306,812.57 (*DONATIONS*), AND MUNICIPAL HEALTH OFFICE IN THE AMOUNT OF P414,000.00 (*MATERNAL & CHILD HEALTH NUTRITION PROGRAM AND BRGY. HEALTH LEADERSHIP & MANAGEMENT PROGRAM (BHLMP)*), AND **CAPITAL OUTLAY** OF THE FOLLOWING: MAYOR'S OFFICE IN THE AMOUNT OF P2,500,000.00 (*IMPROVEMENT OF PUBLIC MARKET*) AND MUNICIPAL HEALTH OFFICE IN THE AMOUNT OF P343,200.00 (*LGU COUNTERPART FOR AMBULANCE*), CHARGEABLE AGAINST THE CY 2016 SURPLUS – EXCESS/OVER COLLECTED INCOME OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive in a letter dated February 13, 2017 requested this Sangguniang Bayan for the urgent passing of a Resolution Approving and Adopting the MDC-EXECOM Resolution No. 2017-01 – *“Resolution Approving the Supplemental Budget Amounting to Four Million Two Hundred Sixty-Six Thousand Twelve Pesos and Fifty Seven Centavos (P4,266,012.57) for Various Expenses for the Year 2017”*;

WHEREAS, the Statement of Supplemental Appropriation, attached to said letter request, prepared by the Municipal Budget Officer and approved by the Municipal Mayor provides for the following requirements:

WHEREAS, Ms. Elma G. Tionsay, OIC-Municipal Treasurer and Mrs. Salvacion T. Trayfalgar, OIC-Municipal Accountant have certified in the Statement of Funding Sources (Supplemental Budget) of Fiscal Year 2017, the availability of P 4,266,012.57 out of excess/over collected income or Surplus from CY 2016;

WHEREAS, the Municipal Development Council- Executive Committee in its February 13, 2017 meeting at the Mayor’s Office of the Tigbauan Municipal Building through MDC-EXECOM Resolution No. 2017-01 approved the above-said supplemental budget for FY 2017;

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that “No money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law”, which necessitates the passing of an ordinance before LGU Tigbauan can validly utilize the abovementioned Supplemental Budget;

NOW, THEREFORE, BE IT ENACTED, THAT:

**SECTION 1. SOURCES OF FUNDS**

The Municipality of Tigbauan has available funds for appropriation and supplemental budget in the total amount of P4,266,012.57 from Surplus in CY 2016 as certified correct by Ms. Elma G. Tionsay, OIC-Municipal Treasurer and Mrs. Salvacion T. Trayfalgar, OIC-Municipal Accountant as attached herewith.

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected shall continue to be in full force or effect.

SECTION 5. EFFECTIVITY. The provisions of this Ordinance shall take effect upon its approval.
