Appropriation Ordinance No. 2017-004

AN ORDINANCE FOR THE AUGMENTATION OF FUNDS AMOUNTING TO ONE MILLION FIVE HUNDRED THIRTY NINE THOUSAND FIVE HUNDRED NINETY SEVEN PESOS AND FORTY NINE CENTAVOS (P1,539,597.49) FOR THE MONETIZATION OF LEAVE CREDITS OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN EMPLOYEES FROM THE SAVINGS OF PERSONAL SERVICES IN VARIOUS OFFICES FOR THE PERIOD JANUARY 1, 2017 TO JUNE 27, 2017.

WHEREAS, the Local Chief Executive in a letter dated June 27, 2017, requested this Sangguniang Bayan for the urgent passing of an Appropriation Ordinance for the Augmentation of Funds for the Monetization of Leave Credits of LGU Tigbauan Employees in the amount of One Million Five Hundred Thirty Nine Thousand Five Hundred Ninety Seven Pesos and Forty Nine Centavos (P1,539,597.49) from the Savings of Personal Services in Various Offices;

WHEREAS, a certification was issued by Members of the Local Finance Committee, namely: *Mr. Jimmy T. Tupas, MPDC, Mrs. Pacita T. Ledesma, Municipal Budget Officer, Ms. Elma G. Tionsay, OIC-Municipal Treasurer and Mrs. Linda Fe Camiña, OIC-Municipal Accountant*, certifying that the total amount of P1,539,597.49 (*which are considered as Savings from the Budget of Personal Services in Various Offices for the Period January 1, 2017 to June 27, 2017*) is available to be augmented to the Terminal Leave Benefits Budget of the Office of the Municipal Mayor;

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that: *"No money shall be paid out of the local treasury except in pursuance of an appropriation's ordinance or law"*;


NOW THEREFORE, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, the following Appropriation Ordinance:

- Section 1.** The total amount of P1,539,597.49 (*which are considered as Savings from the Budget of Personal Services in various offices for the period January 1, 2017 to June 27, 2017*) is hereby augmented to the Terminal Leave Benefits Budget of the Office of the Municipal Mayor (*hereto attached as Annex "A" and forming part of this ordinance*);
- Section 2.** Pertinent provisions of the Local Government Code of 1991 and its implementing rules and regulations applicable to the augmentation of funds from savings in the other items within the same class of expenditures shall be accordingly complied with;
- Section 3.** Augmentation of funds from the Savings of the Budget of Personal Services in various offices (*for the period January 1, 2017 to June 27, 2017*) for the payment of the Monetization of Leave Credits of LGU Tigbauan Employees as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures.
- Section 4.** Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code of 1991 and other laws shall be a personal liability of the official or employee responsible therefore.
- Section 5.** EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon the approval thereof.

RESOLVED FURTHER, to forward copies of this Appropriation Ordinance to the Office of the Municipal Mayor, Provincial Budget Officer, Sangguniang Panlalawigan, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Accountant and to all concerned for their information and appropriate action.
