AN ORDINANCE APPROPRIATING A SUPPLEMENTAL BUDGET FOR FISCAL YEAR 2017 IN THE AMOUNT OF NINE HUNDRED NINETY THOUSAND TWO HUNDRED THREE PESOS (P990,203.00)FOR THE IMPLEMENTATION OF THE FIFTY PERCENT (50%) SECOND TRANCHE COMPENSATION ADJUSTMENT OF THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN,PROVINCE OF ILOILO AS PER DBM LBC NO. 113, DATED JANUARY 5, 2017 TO BE TAKEN FROM THE PERSONAL SERVICES APPROPRIATIONS SAVINGS FROM VARIOUS OFFICES OF THE MUNICIPALITY OF TIGBAUAN FOR THE PERIOD ENDING JUNE 30, 2017 (GENERAL FUND SAVINGS - IN THE AMOUNT OF NINE HUNDRED TWENTY FIVE THOUSAND FOUR HUNDRED THREE PESOS (P925,403.00))AND SPECIAL ACCOUNT SAVINGS - IN THE AMOUNT OF SIXTY FOUR THOUSAND EIGHT HUNDRED PESOS (P64,800.00))

WHEREAS, the Local Chief Executive in a letter dated July 17, 2017 requested this Sangguniang Bayan for the urgent passage of this Appropriation Ordinance and Supplemental Budget for the implementation of the fifty percent (50%) second tranche compensation adjustment of the municipal officials and employees of the Local Government Unit of Tigbauan as per DBM LBC No. 113, dated January 5, 2017 with the following attached documents:

- a.) Statement of Supplemental Appropriation, prepared by the Municipal Budget Officer and approved by the Municipal Mayor;
- b.) Statement of Funding Sources (Supplemental Budget) of Fiscal Year 2017, certified by Ms. Elma G. Tionsay, OIC-Municipal Treasurer and Mrs. Linda Fe T. Camiña, OIC-Municipal Accountant.

WHEREAS, Executive Order No. 201, s. 2016 approved by the President on February 19, 2016 entitled *"Modifying the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of Additional Benefits for Both Civilian and Military and Uniformed Personnel"* was signed by the President in accordance with the authority vested in him under Presidential Decree (PD) No. 985, PD No. 1597, Republic Act (RA) No. 6758, and Congress Joint Resolution (JR) No. 4 s. 2009;

WHEREAS, pursuant to the aforementioned EO No. 201, s. 2016, the Department of Budget and Management issued Local Budget Circular No. 113 dated January 5, 2017 prescribing the guidelines, rules and regulations for the implementation of the second tranche compensation adjustment in local government units (LGUs);

WHEREAS, for LGU-Tigbauan which is a second class municipality, the grant of said Second Tranche Compensation Adjustment was not included in its FY 2017 Annual Budget;

WHEREAS, ANNEX "A-4" of DBM Local Budget Circular No. 113 provides the *"Second Tranche Monthly Salary Schedule For Local Government Personnel In Fourth Class Provinces And Cities/Second Class Municipalities Effective Not Earlier Than January 1, 2017"*;

WHEREAS, a certification was issued by Members of the Local Finance Committee, namely: *Mr. Jimmy T. Tupas, MPDC, Mrs. Pacita T. Ledesma, Municipal Budget Officer, Ms. Elma G. Tionsay, OIC-Municipal Treasurer and Mrs. Linda Fe T. Camiña, OIC-Municipal Accountant*, indicating the P990,203.00 totalSavings from various offices of the Municipality of Tigbauan from personal services appropriations for the period ending June 30, 2017, itemized as follows:

WHEREAS, the Municipal Development Council – Executive Committee (MDC-ExeCom) in its July 13, 2017, meeting through MDC Resolution No. 2017-04 approved the above-said supplemental budget for FY 2017;

WHEREAS, the implementation of this 50% 2<sup>ND</sup> tranche salary adjustments of the Municipal Officials and Employees will be effective on July 1, 2017, including its government share contributions and personnel benefits;

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that: *"No money shall be paid out of the local treasury except in pursuance of an appropriation's ordinance or law"*.

**NOW THEREFORE**, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, the following Appropriation Ordinance and Supplemental Budget:

**SECTION 1. SOURCES OF FUNDS**

The Municipality of Tigbauan has available funds for appropriation and supplemental budget in the total amount of P 990,203.00 to be taken from Savings from various offices of the Municipality of Tigbauan from personal services appropriations for the period ending June 30, 2017 as certified correct by Mr. Jimmy Tupas, MPDC, Ms. Elma G. Tionsay, OIC-Municipal Treasurer, Mrs. Pacita T. Ledesma, Municipal Budget Officer and Mrs. Linda Fe T. Camiña, OIC-Municipal Accountant.

**SECTION 2. USE OF FUNDS**

The available funds shall be appropriated and supplemented for the implementation of the Fifty Percent (50%) Second Tranche Compensation Adjustment of the Municipal Officials and Employees of the Local Government Unit of Tigbauan as per DBM LBC No. 113, dated January 5, 2017;

**SECTION 3.** The appropriated amounts as embodied in this Appropriation Ordinance and Supplemental Budget shall be subject to usual accounting and auditing rules and procedures. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditures of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

**SECTION 4. SEPARABILITY CLAUSE.** If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected shall continue to be in full force or effect.

**SECTION 5. EFFECTIVITY.** The provisions of this Ordinance shall take effect upon its approval.
