Appropriation Ordinance No. 2018-002

AN ORDINANCE FOR THE AUGMENTATION OF FUNDS AMOUNTING TO ONE MILLION NINE HUNDRED SEVENTY-ONE THOUSAND, ONE HUNDRED EIGHTY-EIGHT PESOS AND THIRTY-SEVEN CENTAVOS (P1,971,188.37) SAVINGS FROM PERSONAL SERVICES APPROPRIATION FOR THE PERIOD JANUARY 1 TO APRIL 30, 2018 FOR THE IMPLEMENTATION OF THE FIFTY PERCENT (50%) THIRD TRANCHE COMPENSATION ADJUSTMENT FOR LOCAL GOVERNMENT PERSONNEL IN SECOND CLASS MUNICIPALITIES AS PER DBM LBC NO. 113, DATED JANUARY 5, 2017, EFFECTIVE MAY 1 - DECEMBER 31, 2018, OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive in a letter dated April 23, 2018 requested this Sangguniang Bayan for the urgent passage of *an ordinance approving and conforming MDC Resolution No. 2018-05, dated April 20, 2018, “Resolution Approving Augmentation of Funds in the Amount of One Million Nine Hundred Seventy-One Thousand, One Hundred Eighty-Eight Pesos and Thirty-Seven Centavos (P1,971,188.37) Savings from Personal Services Appropriation for the Period January 1 To April 30, 2018 for the Implementation of the 50% Third Tranche Compensation Adjustment for Local Government Personnel in Second Class Municipalities As Per DBM LBC No. 113, Dated January 5, 2017, Effective April 1-December 31, 2018, of the Municipality of Tigbauan, Province Of Iloilo”;*

WHEREAS, Executive Order No. 201, s. 2016, entitled “*Modifying the Salary Schedule for Civilian Government and Authorizing the Grant of Additional Benefits for Both Civilian and Military and Uniformed Personnel*” was signed by the President in accordance with the authority vested in him under President Decree (PD) No. 9851, PD No. 15972, Republic Act (RA) No. 67583, and Congress Joint Resolution (JR) No. 44, s. 2009;

WHEREAS, the issuance of Executive Order No. 201 is consistent with the governing principle of the Compensation and Position Classification System, as espoused under Congress JR No. 4, that compensation of government personnel shall be generally comparable with those in the private sector doing comparable work in order to attract, retain, and motivate a core of competent civil servants;

WHEREAS, Executive Order No. 201 provided for at least a four-year (2016-2019) implementation of the compensation adjustment;

WHEREAS, the Municipal Development Council’s participation is necessary in the approval of the 50% Implementation of Third Tranche Compensation Adjustment for Local Government Personnel in Second Class Municipalities as per DBM LBC No.113, dated January 5, 2017, of the Municipality of Tigbauan;

WHEREAS, there is a need for augmentation of funds in the amount of *One Million Nine Hundred Seventy-One Thousand, One Hundred Eighty-Eight Pesos and Thirty-Seven Centavos (P1,971,188.37)* savings from Personal Services appropriation for the period January 1 - April 30, 2018 for the 50% implementation of Third Tranche Compensation Adjustment for Local Government Personnel in Second Class Municipalities as per DBM LBC No.113, dated January 5, 2017, effective May 1 - December 31, 2018, since Fiscal Year 2018 Appropriation Ordinance only includes full implementation of Second Tranche Compensation Adjustment for Local Government Personnel, Municipality of Tigbauan, Province of Iloilo;

WHEREAS, a certification was issued by Members of the Local Finance Committee, namely: Mr. Jimmy T. Tupas, MDC, Mrs. Pacita T. Ledesma, Municipal Budget Officer, Ms. Elma G. Tionsay, OIC-Municipal Treasurer and Mrs. Mary Grace M. Trio, OIC-Municipal Accountant, certifying that the amount of P1,971,188.37 savings from Personal Services Appropriation for the Period January 1 to April 30, 2018 is available to be augmented for the 50% Implementation of the Third Tranche Compensation Adjustment for Local Government Personnel in Second Class Municipalities as per DBM LBC No. 113, dated January 5, 2017, Effective May 1- December 31, 2018, of the Municipality of Tigbauan, Province of Iloilo, itemized as follows:

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that: *“No money shall be paid out of the local treasury except in pursuance of an appropriation’s ordinance or law”.*

NOW THEREFORE, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, the following Appropriation Ordinance:

Section 1. The total amount of P1,971,188.37 (*considered as Savings from the Budget of Personal Services in various offices for the period January 1-April 30, 2018*) is hereby augmented for the 50% implementation of the Third Tranche Compensation Adjustment for Local Government Personnel in Second Class Municipalities as per DBM LBC No. 113, dated January 5, 2017, Effective May 1- December 31, 2018, of the Municipality of Tigbauan, Province of Iloilo (*hereto attached as Annex “A” and forming part of this ordinance*);

Section 2. Pertinent provisions of the Local Government Code and its implementing rules and regulations applicable to the augmentation of funds from savings in the other items within the same class of expenditures shall be accordingly complied with;

Section 3. Augmentation of funds as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures.

Section 4. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code and other laws shall be a personal liability of the official/s or employee/s responsible therefore.

Section 5. EFFECTVITY. This Appropriation Ordinance shall take effect immediately upon the approval thereof.

RESOLVED FURTHER, to forward copies of this Appropriation Ordinance to the Office of the Municipal Mayor, Provincial Budget Officer, Sangguniang Panlalawigan, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Office, the Municipal Accountant and to all concerned for their information and appropriate action.
