Appropriation Ordinance No. 2018-004

AN ORDINANCE FOR THE AUGMENTATION OF FUNDS AMOUNTING TO ONE HUNDRED FIFTEEN THOUSAND TWO HUNDRED NINETY THREE PESOS AND THIRTY TWO CENTAVOS (P115,293.32) FROM CY 2018 PERSONAL SERVICES SAVINGS OF VACANT FUNDED POSITIONS FROM THE DIFFERENT OFFICES STARTING MAY 1, 2018 TO JUNE 30, 2018 FOR THE PAYMENT OF MONETIZATION OF LEAVE CREDITS OF FOUR MUNICIPAL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive, in a letter dated June 11, 2018, requested this Sangguniang Bayan for an urgent authority to augment items in the executive budget for CY 2018 of this municipality from unexpended balances or savings in the same expense class to facilitate the needed funds for the monetization of the leave credits of four municipal employees of this LGU amounting to P115,293.32 namely: Ronell T. Conadera, Araceli S. Llasos, Nerissa T. Agoriles and Kenny T. Arias;

WHEREAS, a Summary of the Source of Funds was certified correct by Mrs. Myra Gene G. Gautier, *OIC-Municipal Budget Officer*, Ms. Elma G. Tionsay, *OIC-Municipal Treasurer*, Mr. Jimmy T. Tupas, *MPDC* and Mrs. Mary Grace M. Trio, *OIC-Municipal Accountant* and approved by Atty. Suzette T. Alquisada, *Municipal Mayor*, indicating the availability of funds from CY 2018 Personal Services Savings of Vacant-Funded Positions from Different Offices starting May 1, 2018 to June 30, 2018 to be augmented for the Monetization of Leave Credits of four municipal employees in the amount of P115,293.32;


WHEREAS, Section 336 of RA 7160 or the Local Government Code of 1991 empowers the Sanggunian to authorize the local chief executive to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that: *“No money shall be paid out of the local treasury except in pursuance of an appropriation’s ordinance or law”*.

NOW, THEREFORE, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:

- Section 1.** The amount of P115,293.32 from CY 2018 Personal Services Savings of Vacant-Funded Positions from different offices starting May 1, 2018 to June 30, 2018 of this LGU is hereby augmented for the payment of Monetization of Leave Credits of four municipal employees of this municipality;
- Section 2.** Pertinent provisions of the Local Government Code and its implementing rules and regulations applicable to the authority herein granted shall be accordingly complied with;
- Section 3.** Augmentation of budget items from any savings within the same expense class and the utilization of funds related thereto as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures;
- Section 4.** Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore;
- Section 5.** EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon the approval thereof.
