**Appropriation Ordinance No. 2018-006**

AN ORDINANCE FOR THE AUGMENTATION OF FUNDS AMOUNTING TO TWO HUNDRED TEN THOUSAND SIX HUNDRED FORTY-SEVEN PESOS AND ELEVEN CENTAVOS (P210,647.11) FROM CY 2018 PERSONAL SERVICES SAVINGS OF VACANT FUNDED POSITION - OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT OFFICE AND MUNICIPAL BUDGET OFFICE FROM MAY 1, 2018 TO AUGUST 31, 2018 FOR THE PAYMENT OF MONETIZATION OF LEAVE CREDITS OF TWO (2) MUNICIPAL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO.

**WHEREAS**, the Local Chief Executive, in a letter dated August 22, 2018, endorsed the request of two municipal employees from the Municipal Planning and Development Office and Municipal Budget Office for monetization of their leave benefits namely: Jimmy Tupas in the amount of P150,917.56 and Jean Ledesma in the amount of P59,729.55;

**WHEREAS**, a Summary of the Source of Funds/Source of Funds was certified correct by Mrs. Myra Gene G. Gautier, OIC-Municipal Budget Officer, Ms. Elma G. Tionsay, OIC-Municipal Treasurer, Mr. Jimmy T. Tupas, MPDC and Mrs. Mary Grace M. Trio, OIC-Municipal Accountant and approved by Atty. Suzette T. Alquisada, Municipal Mayor, indicating the availability of funds from CY 2018 Personal Services Savings of Vacant-Funded Positions - Municipal Planning and Development Office and Municipal Budget Office from May 1, 2018 to August 31, 2018 to be augmented for the Monetization of Leave Credits of two municipal employees in the amount of P210,647.11;

**WHEREAS**, Section 336 of RA 7160 or the Local Government Code of 1991 empowers the Sanggunian to authorize the local chief executive or the Presiding Officer of the Sanggunian concerned to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;


**WHEREAS**, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that: *“No money shall be paid out of the local treasury except in pursuance of an appropriation’s ordinance or law”*.

**NOW, THEREFORE**, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:


- Section 1.** The amount of P210,647.11 from CY 2018 Personal Services Savings of Vacant-Funded Positions - Municipal Planning and Development Office and Municipal Budget Office from May 1, 2018 to August 31, 2018 of this LGU is hereby augmented for the payment of Monetization of Leave Benefits of two municipal employees of this municipality;
- Section 2.** Pertinent provisions of the Local Government Code and its implementing rules and regulations applicable to the authority herein granted shall be accordingly complied with;
- Section 3.** Augmentation of budget items from any savings within the same expense class and the utilization of funds related thereto as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures;
- Section 4.** Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore;
- Section 5.** **EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon the approval thereof.
