**Appropriation Ordinance No. 2020-001
Supplemental Budget No. 2020-001**

AN ORDINANCE APPROPRIATING FOR A SUPPLEMENTAL BUDGET IN THE TOTAL AMOUNT OF FIFTEEN MILLION TWO HUNDRED THOUSAND PESOS (P15,200,000.00) FOR THE IMPROVEMENT OF MUNICIPAL GROUNDS-PAVEMENT STONES IN FRONT OF MUNICIPAL BUILDING IN THE AMOUNT OF FOUR MILLION PESOS (P4,000,000.00), PROCUREMENT OF ONE (1) UNIT GARBAGE COMPACTOR AND TWO (2) UNITS DUMPTRUCK IN THE AMOUNT OF ELEVEN MILLION TWO HUNDRED THOUSAND PESOS (P11,200,000.00) CHARGEABLE AGAINST THE CY 2019 SAVINGS/SURPLUS: CONTINUING, MAYOR'S-EXECUTIVE (PLAZA, PARKS AND MONUMENTS- P4,000,000.00), CONTINUING PRIOR YEARS 20% IRA FUND (ENVIRONMENT SERVICES SECTOR- P8,600,000.00 AND ECONOMIC SERVICES SECTOR- P2,600,000.00) RESPECTIVELY, OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive in a letter dated March 3, 2020 requested this Sangguniang Bayan for the urgent passage of an ordinance approving and conforming MDC-Executive Committee Resolution No. 2020-01, dated March 2, 2020, entitled: "Resolution Approving the Supplemental Appropriation for CY 2020 for the Improvement of Municipal Grounds-Pavement Stones in Front of Municipal Building (Mayor's Office, Plaza, Parks and Monuments) in the Amount of Four Million Pesos (P4,000,000.00), Procurement of Garbage Compactor and Dumptruck (Economic Services Sector) in the Amount of Eight Million Six Hundred Thousand Pesos (P8,600,000.00) and Procurement of Dumptruck (Environmental Services Sector) in the

Amount of Two Million Six Hundred Thousand Pesos (P2,600,000.00) With A Total Supplemental Appropriation Of Fifteen Million Two Hundred Thousand Pesos (P15,200,000.00) of the Municipality of Tigbauan, Province of Iloilo”;

WHEREAS, as reflected in the attached **Summary of the Source of Funds for Supplemental Budget CY 2020** certified correct by the Local Finance Committee Members (namely: Ms. Myra Gene Gautier, (OIC-Municipal Budget Officer), Ms. Elma G. Tionsay, (Municipal Treasurer), Mrs. Mary Grace M. Trio, (OIC-Municipal Accountant), Mr. Jimmy T. Tupas, (Municipal Planning and Development Coordinator) and approved by the Municipal Mayor, Atty. Suzette T. Alquisada), there is a total amount of **Fifteen Million Two Hundred Thousand Pesos (P15,200,000.00)** CY 2019 Savings/Surplus in the Continuing, Mayor’s-Executive (Plaza, Parks and Monuments- P4,000,000.00), Continuing Prior Years 20% IRA Fund (Environment Services Sector- P8,600,000.00 and Economic Services Sector- P2,600,000.00) (as itemized and reflected under Section 1 of this ordinance);

WHEREAS, a **Statement of Supplemental Appropriations CY 2020** (prepared by Ms. Myra Gene G. Gautier, OIC-Municipal Budget Officer and approved by Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor), stating that the said P15,200,000.00 CY 2019 savings/surplus is intended for the Improvement of Municipal Grounds-Pavement Stones in Front of Municipal Building; Procurement of One (1) Unit Garbage Compactor and Two (2) Units Dumptruck of this municipality (also itemized and reflected under Section 2 of this ordinance);

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that “No money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law”. Hence, it necessitates the passing of an ordinance before the LGU-Tigbauan can validly utilize the abovementioned supplemental budget;

NOW, THEREFORE, BE IT ENACTED, THAT:

SECTION 1. SOURCES OF FUNDS

The Municipality of Tigbauan has available funds for appropriation and supplemental budget in the total amount of **Fifteen Million Two Hundred Thousand Pesos (P15,200,000.00)** from CY 2019 Savings/Surplus itemized as follows:

SECTION 3. The CY 2020 Annual Investment Program (Supplemental) Appropriation reflecting the different plans, programs, projects and activities of the Supplemental Budget 2020 shall form as an integral part of this Appropriation Ordinance.

SECTION 4. The appropriated amounts as embodied in this Appropriation Ordinance and Supplemental Budget shall be subject to usual accounting and auditing rules and procedures. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditures of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

SECTION 5. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected shall continue to be in full force or effect.

SECTION 6. EFFECTIVITY. The provisions of this Ordinance shall take effect upon its approval.
