WHEREAS, "Salary Standardization Law of 2019," (RA No. 11466) modifies the Salary Schedule for Civilian Personnel and authorizes the grant of additional benefits. The modified Salary Schedule for Civilian Personnel shall be implemented in four tranches, from FY 2020 to FY 2023;

WHEREAS, said law also provides for the granting of the Mid-Year Bonus as part of the Incentives under the Total Compensation Framework (TCF). Likewise, it states that the Program on Awards and Incentives for Service Excellence (PRAISE) instituted by the Civil Service Commission (CSC) pursuant to the provisions of Executive Order (EO) No. 292 (Administrative Code of 1987) shall be categorized under the incentives component of the TCF;

WHEREAS, Administrative Order (AO) No. 26 dated March 23, 2020 authorizes the grant of Hazard Pay, to be called as COVID-19 Hazard Pay, to government employees and workers engaged through contract of service (COS) or job order (JO) basis who physically report for work during the implementation of an Enhanced Community Quarantine in their respective work stations, in an amount not exceeding P500/day per person;

NOW THEREFORE, be it enacted by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, the following Appropriation Ordinance:

Section 1. The total amount of Four Million Fifty-Two Thousand Pesos (P4,052,000.00), Savings from Personal Services Appropriation for the Period January 1 to May 31, 2020 for the Payment of the Full Implementation of the First Tranche of the Modified Salary Schedule for LGU Personnel Pursuant to Republic Act No. 11466 for Second Class LGUs, as Per DBM LBC No.121, Dated January 24, 2020, Effective June 1-December 31, 2020, of the Municipality of Tigbauan, Province of Iloilo, summarized as follows:

Section 1.
