AN ORDINANCE FOR SUPPLEMENTAL BUDGET APPROVING THE RE-PROGRAMMING OF FIVE HUNDRED THIRTEEN THOUSAND SEVEN HUNDRED TWENTY TWO PESOS AND FIFTY EIGHT CENTAVOS (P513,722.58) BALANCES OF CONTINUING 20% DEVELOPMENT FUND FROM VARIOUS HEALTH AND EMERGENCY RELATED PROGRAMS (*PER CERTIFICATION ISSUED BY THE LOCAL FINANCE COMMITTEE*) FOR THE PURCHASE OF ONE (1) GENERATOR SET WITH ACCESSORIES AND ELECTRICAL SUPPLIES OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipal Mayor in a letter dated July 6, 2021 requested this Sangguniang Bayan for the URGENT passing of a "*Resolution Re-Programming the Balances of Continuing 20% Development Fund From Various Health and Emergency Related Programs for the Purchase Of One (1) Generator Set With Accessories And Electrical Supplies In The Amount Of Five Hundred Thirteen Thousand Seven Hundred Twenty Two Pesos And Fifty Eight Centavos (P513,722.58);*"

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that "*No money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law*"; thus, necessitates the passing of an ordinance before the LGU-Tigbauan can validly utilize the abovementioned supplemental budget/reprogramming of funds/balances;

WHEREAS, a **Certification** dated July 05, 2021 was issued by the Local Finance Committee Members (namely: Ms. Myra Gene Gautier, Municipal Budget Officer, Ms. Elma G. Tionsay, Municipal Treasurer, Mrs. Mary Grace Trio, OIC-Municipal Accountant and Mr. Jimmy T. Tupas, MPDC and approved by the Municipal Mayor, Atty. Suzette T. Alquisada), that a total amount of **Five Hundred Thirteen Thousand Seven Hundred Twenty**

Two Pesos and Fifty Eight Centavos (P513,722.58) balances of continuing 20% development fund representing prior years unobligated balances is available for re-programming for the said priority projects of this municipality *(as itemized and reflected under Section 1 of this ordinance)*;

NOW, THEREFORE, BE IT ENACTED, THAT:

SECTION 1. SOURCES OF FUNDS

The Municipality of Tigbauan has available funds for appropriation/reprogramming of balances and supplemental budget in the total amount of **P P513,722.58** from continuing 20% development fund balances *(representing prior years unobligated balances)* itemized as follows:

Improvement of Health Center	P212,452.87
Health and Sanitation	33,151.15
Laboratory and Medical Equipment	66,028.56
Procurement of Rescue and Firefighting facilities	190,750.00
Nutrition Services	<u>11,340.00</u>
Total	P513,722.58

SECTION 2. USE OF FUNDS

The available funds shall be appropriated/reprogrammed and supplemented for the following items of expenditures:

One (1) Generator set (with accessories)	P500,000.00
Electrical Supplies and Expenses for connection	<u>13,722.58</u>
Total	P513,722.58

SECTION 3. The appropriated amounts as embodied in this Appropriation Ordinance and Supplemental Budget shall be subject to usual accounting and auditing rules and procedures. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditures of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected shall continue to be in full force or effect.

SECTION 5. EFFECTIVITY. The provisions of this Ordinance shall take effect upon its approval.
