**Appropriation Ordinance No. 2022-001
Supplemental Budget No. 2022-001**

AN ORDINANCE APPROPRIATING FOR A SUPPLEMENTAL BUDGET IN THE TOTAL AMOUNT OF ONE MILLION THREE HUNDRED FORTY THREE THOUSAND PESOS (P1,343,000.00) TO BE UTILIZED FOR ELECTION EXPENSES OF THE COMMISSION ON ELECTIONS (COMELEC) FOR THE UPCOMING MAY 9, 2022 NATIONAL AND LOCAL ELECTIONS CHARGEABLE AGAINST THE TOTAL EXCESS OF ACTUAL COLLECTIONS FOR THE YEAR 2021 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive in a letter dated March 7, 2022 requested this Sangguniang Bayan for the URGENT passing of an "Appropriation Ordinance for a Supplemental Budget in the Total Amount of One Million Three Hundred Forty Three Thousand Pesos (P1,343,000.00) to be Utilized for Election Expenses of the Commission on Elections (COMELEC) for the Upcoming May 9, 2022 National and Local Elections Chargeable Against The Total Excess of Actual Collections for the Year 2021 of the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, the Municipal Development Council on March 4, 2022 passed Resolution No. 2022-02 entitled: *“Resolution Approving the Supplemental Annual Investment Program (AIP) CY 2022 in the Amount of One Million Three Hundred Forty-Three Thousand Pesos (P1,343,000.00) from the Surplus of Collection for the Year 2021 for COMELEC Expenses for the Upcoming May 9, 2022 National and Local Elections in the Amount of One Million Pesos (P1,000,000.00) and Treasury Services (Other MOE) in the Amount of Three Hundred Forty-Three Thousand Pesos (P343,000.00) of the Municipality of Tigbauan, Province of Iloilo;”*

WHEREAS, Section 13, Section 21 and Section 29 of Batas Pambansa BLG. 881, s.1985, the “Omnibus Election Code of the Philippines” mandated the conduct of National and Local Elections on all elected officials on May 9, 2022;

WHEREAS, as reflected in the **Statement of Funding Sources FY 2022** (certified correct by Ms. Elma G. Tionsay, (Municipal Treasurer) and Mrs. Mary Grace M. Trio, (Municipal Accountant), there is a total amount of **One Million Three Hundred Forty Three Thousand Pesos (P1,343,000.00)** from CY 2021 Revenue Surplus;

WHEREAS, a **Statement of Supplemental Appropriations CY 2022** (prepared by: Ms. Myra Gene Gautier, Municipal Budget Officer and approved by the Municipal Mayor, Atty. Suzette T. Alquisada), also stated that the said P1,343,000.00 is intended for Election Expenses of the COMELEC (itemized and reflected under Section 2 of this ordinance);

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that *“No money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law”*. Hence, it necessitates the passing of an ordinance before the LGU-Tigbauan can validly utilize the abovementioned supplemental budget;

NOW, THEREFORE, BE IT ENACTED, THAT:

SECTION 1. SOURCES OF FUNDS

The Municipality of Tigbauan has available funds for appropriation and supplemental budget in the total amount of **One Million Three Hundred Forty Three Thousand Pesos (P1,343,000.00)** from CY 2021 Revenue Surplus (Total Excess of Actual Collections for the Year 2021).

SECTION 2: USE OF FUNDS

The available funds shall be appropriated and supplemented for the following items of expenditures:

SECTION 3. The appropriated amounts as embodied in this Appropriation Ordinance and Supplemental Budget shall be subject to usual accounting and auditing rules and procedures. Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Expenditures of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected shall continue to be in full force or effect.

SECTION 5. EFFECTIVITY. The provisions of this Ordinance shall take effect upon its approval.
