**Appropriation Ordinance No. 2022-004**

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE AND VICE MAYOR AND PRESIDING OFFICER OF THE SANGGUNIAN TO AUGMENT ANY ITEM IN THE APPROVED 2022 ANNUAL BUDGET FOR THEIR RESPECTIVE OFFICES FROM SAVINGS IN OTHER ITEMS WITHIN THE SAME EXPENSE CLASS OF THEIR RESPECTIVE APPROPRIATIONS PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE.

**WHEREAS**, Calendar Year 2022 is about to end and based on the **Statement of Allotment and Obligations** submitted by the Municipal Budget Office to the Mayor’s Office, some budgeted amounts necessary for the operations of the municipality are already depleted;

**WHEREAS**, the prompt and continuous delivery of basic services to the populace is of paramount concern and responsibility of the local government unit and entails the utilization of funds as appropriated in the approved annual budget;

**WHEREAS**, it is imperative that the expenses which are already depleted be augmented to be taken from savings in the same expense class for the efficient and effective delivery of public service of the Local Government Unit of Tigbauan to its constituents;

**WHEREAS**, Section 336 of the Local Government Code (LGC) expressly provides that Funds shall be available exclusively for the specific purpose for which they have been appropriated and prohibits the transfer of appropriations from one item to another;


**WHEREAS**, said Section 336 of the LGC provides an exception to the above-mentioned general rule, to wit, “...the Local Chief Executive or the Presiding Officer of the sanggunian concerned may, **by ordinance**, be authorized to augment any item in the approved annual budget of their respective offices from savings in other items within the same expense class of their respective appropriations.”

**NOW, THEREFORE, BE IT ENACTED** by the Sangguniang Bayan that:

- Section 1.** Authority is hereby granted to Atty. Virgilio T. Teruel, Local Chief Executive and Lugen T. Ortilano, Vice Mayor and Presiding Officer, to augment any items in the 2022 Approved Annual Budgets for the Executive and Legislative Departments from their savings in the other items within the same class of expenditures as mandated by the Local Government Code.
- Section 2.** Pertinent provisions of the Local Government Code and its implementing rules and regulations applicable to the authority herein granted shall be accordingly complied with.
- Section 3.** Augmentation of budget items from any savings within the same expense class and the utilization of funds related thereto as embodied in this Appropriation Ordinance shall be subject to usual accounting and auditing rules and procedures.
- Section 4.** Compliance with all existing laws, rules and regulations shall be the responsibility of the officials authorizing the disbursement of funds. Utilization of funds in violation of the Local Government Code and other laws shall be a personal liability of the official or employee responsible therefore.
- Section 5.** EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon the approval thereof.
