AN ORDINANCE APPROPRIATING FOR A SUPPLEMENTAL BUDGET IN THE TOTAL AMOUNT OF SEVEN HUNDRED TWENTY FIVE THOUSAND SIX HUNDRED EIGHTEEN AND 92/100 PESOS (P725,618.92) FROM CY 2022 PERSONAL SERVICES SAVINGS OF VACANT-FUNDED POSITIONS IN THE GENERAL FUND TO BE UTILIZED FOR: (1) PAYMENT OF BACK WAGES OF MAO EUGENIA T. SAYSON; (2) GRANT OF OVER TIME PAY OF GENERAL SERVICES PERSONNEL DURING THE SALUDAN AND CHRISTMAS PREPARATIONS; AND (3) HONORARIA OF GOVERNMENT PERSONNEL INVOLVED IN GOVERNMENT PROCUREMENT (BAC) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipal Mayor in a letter dated December 5, 2022 requested this August Body for the URGENT passage of a “An Ordinance Appropriating For A Supplemental Budget In The Total Amount Of Seven Hundred Twenty Five Thousand Six Hundred Eighteen Pesos And Ninety Two Centavos (Php 725,618.92) From CY 2022 Personal Services Savings Of Vacant-Funded Positions In The General Fund To Be Utilized For: (1) Payment Of Back Wages Of MAO Eugenia T.

Sayson; (2) Grant Of Over Time Pay Of General Services Personnel During The Saludan And Christmas Preparations; And (3) Honoraria Of Government Personnel Involved In Government Procurement (BAC);”

WHEREAS, as reflected in the **Statement of Funding Sources FY 2022** (certified correct by Ms. Elma G. Tionsay, (Municipal Treasurer) and Mrs. Mary Grace M. Trio, (OIC-Municipal Accountant), said amount of **Seven Hundred Twenty Five Thousand Six Hundred Eighteen Pesos and Ninety Two Centavos (P725,618.92)** (from CY 2022 - Personal Services Savings of Vacant-Funded Positions of the Different Offices as of November 30, 2022 for the Payment of Back Wages of MAO Eugenia T. Sayson, Grant of Over Time Pay of General Services Personnel During Saludan and Christmas Preparations and Honoraria of Government Personnel Involved in Government Procurement (BAC) as itemized and reflected under Section 1 of this ordinance) is available for supplemental appropriation;

WHEREAS, a **Statement of Supplemental Appropriations CY 2022** (prepared by: Ms. Myra Gene Gautier, Municipal Budget Officer and approved by the Municipal Mayor, Atty. Virgilio T. Teruel), also stated that the said amount of P725,618.92 is intended for the Payment of Back Wages of MAO Eugenia T. Sayson, Grant of Over Time Pay of General Services Personnel During Saludan and Christmas Preparations and Honoraria of Government Personnel Involved in Government Procurement (BAC) (also itemized and reflected under Section 2 of this ordinance);

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that “No money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law”. Hence, it necessitates the passing of an ordinance before the LGU-Tigbauan can validly utilize the abovementioned supplemental appropriation/budget;

NOW, THEREFORE, BE IT ENACTED, THAT:

SECTION 1. SOURCES OF FUNDS

The Municipality of Tigbauan has available funds for appropriation and supplemental budget in the total amount of **Seven Hundred Twenty Five Thousand Six Hundred Eighteen Pesos and Ninety Two Centavos (P725,618.92)** from CY 2022 - Personal Services Savings of Vacant-Funded Positions of the different Offices of this municipality as of November 30, 2022, to wit:

SECTION 5. EFFECTIVITY. The provisions of this Ordinance shall take effect upon its approval.
