AN ORDINANCE COMPELING ALL MUNICIPAL EMPLOYEES, EXCEPT POLICEMEN TO WEAR A UNIFORM AND NAMEPLATE DURING OFFICE HOURS AND PROVIDING PENALTY THEREOF

BE IT ORDAINED AS FOLLOWS:

Section 1 - All employees paid from the Municipal Fund shall, at all times, wear a uniform during office hours.

Section 2 - Male employees shall wear dark trousers and short-sleeve white shirt with nameplate and shoes to match.

Section 3 - Female employees shall wear dark skirt with white inexpensive blouse with nameplate and shoes to match.

Section 4 - Employees violating this Ordinance shall suffer a penalty of a fine equivalent to one day salary for every violation hereof.

Section 5 - This Ordinance shall take effect on August 1, 1968.
