The opening prayers was led by the Presiding Officer.
Attendance was checked by the Secretary and the reading of the
previous minutes followed. Minutes read was approved.

The tentative schedule of Kaadlawan sang Iloilo was read

Ordinance No. 64, s. 1977

AN ORDINANCE PROHIBITING THE SALE AND PURCHASE OF ANIMAL MANURE
IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, PROVIDING
PENALTY FOR THE VIOLATION THEREOF AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Members of Bagongbang Bayan,
Tigbauan, Iloilo that:

Article I - Name and Title of Ordinance

Section I - This Ordinance shall be known as the
Ordinance Prohibiting the selling
and buying and transferring of Animal
Manure in the Municipality of Tigbauan,
Iloilo.

Section II - Hereinafter no person shall sell or buy
animal manure in the Municipality of
Tigbauan, Iloilo.

Section II-A - To read as follows:

Transfer of animal manure to other places
outside of the geographical jurisdiction
of this municipality is prohibited.

Section III - All Barangay Heads and Barangay Councils
are hereby authorized to campaign and
implement this Ordinance in their respective
barangays.

Article II - Penal Provisions

Section I - Violation of the provisions of this Ordinance shall be fine of fifty (P50.00) pesos
to one hundred (P100.00) pesos or an imprisonment of 1 to 10 days or both upon the
discretion of the Honorable Court.

Article III - Effectivity

This Ordinance shall take effect
upon approval by the proper
authorities.
