The Secretary led the opening prayers and the Presiding Officer declared the session open. Minutes of the previous session was spared after Honorable Lorenzo Torrilla, Sr. moved that it be read next time.

RESOLUTION PROHIBITING THE INDISCRIMINATE USE OF LOUDSPEAKERS AND JUKEBOXES IN THE PUBLIC MARKET IN THIS MUNICIPALITY DURING MARKET DAYS.

WHEREAS, indiscriminate use of loudspeakers and jukeboxes in the public market of this Municipality during market days becomes a public nuisance;

WHEREAS, the deafening sounds from these gadgets distract market collectors, so much so, that they often commit errors in accounting their collections;

NOW, THEREFORE, on motion of Honorable Vicente Tuarez and seconded by Honorable Jose Tuvida;

RESOLVE, as it is hereby resolved to prohibit the indiscriminate use of loudspeakers and jukeboxes in the public market of this municipality during market days;

RESOLVED FURTHER, to forward copies of this resolution to Mrs. Nelly G. Serdina, Municipal Treasurer for her information and favorable action to the Office of the Station Commander, to the market stallholders and market vendors using these gadgets for their information and cooperation in its implementation.

AN ORDINANCE PROHIBITING THE INDISCRIMINATE USE OF LOUDSPEAKERS AND JUKEBOXES IN THE PUBLIC MARKET DURING MARKET DAYS.

Article I - Name and Title of Ordinance
