RESOLUTION IMPOSING AN ANNUAL MUNICIPAL LICENSE FEE FOR GATHERERS
OF LAMPIRONG OR CAPIZ SHELLS P10.00 FOR HAND GATHERERS, P25.00
FOR GATHERERS USING PUMPBOTS, P50.00 FOR GATHERERS USING COMPRES-
SORS, P300.00 FOR BUYERS OR PURCHASERS OF SHELLS OF OUTER COVERING
OF LAMPIRONG OR CAPIZ SHELLS CAUGHT IN THE MUNICIPAL WATERS OF
TIGBAUAN.

WHEREAS, "Lampirong" or Capiz shells abound in the municipal
waters of Tigbauan;

WHEREAS, "Lampirong" or Capiz shells are gathered by diverse
methods and provide lucrative trade for gatherers of lampirong or
Capiz shells and also buyers of the outer shells of lampirong or
Capiz shells;

NOW, THEREFORE, on motion of Honorable Leovigildo Diaz and
seconded by Honorable Esteban Tundinang,

RESOLVE, as it is hereby resolved to impose an annual
municipal license fee of P10.00 for hand gatherers, P25.00 for
gatherers using pumpboats, P50.00 for gatherers compressors,
P300.00 for buyers or purchasers of shells of outer covering of
lampirong or Capiz shells caught in the municipal waters of this
municipality,

RESOLVED FURTHER, to forward copies of this resolution to
the Bureau of Fisheries and Aquatic Resources, Arcadia Building,
Quezon Avenue, Makati, Manila, the Secretary of the Department
of Natural Resources for his information and approval and to
furnish all the copies of this resolution to all municipalities
along the shore of the First District for their information and
to seek their cooperation so that a uniform legislation will be
levied on gatherers as well as buyers of Capiz shells or
lampirong.

Municipal Ordinance No. 66, s. 1977

AN ORDINANCE TO IMPOSE AN ANNUAL MUNICIPAL LICENSE FEE OF P 10.00 FOR HAND GATHERING, P 25.00 FOR GATHERERS USING PUMPBOTS, P 50.00 FOR GATHERERS USING COMPRESSORS, P 300.00 TO BUYERS OR PURCHASERS OF SHELLS CAUGHT IN THE MUNICIPAL WATERS OF TIGBAUAN.

Article I - Name and Title of Ordinance

Section 1 - An Ordinance imposing an Annual Municipal License fee on gatherers of "Lampirang" or Capis shells in the Municipal waters of Tigbauan and on buyers or purchasers of shells or outer covering of Lampirang or Capis shells.

Section 2 - This Ordinance shall be known as an Ordinance to impose an Annual Municipal License Fee of P 10.00 for hand gatherers, P 25.00 for gatherers using pumpboats, P 50.00 for gatherers using compressors, P 300.00 to buyers or purchasers of shells caught in the Municipal waters of Tigbauan.

Article II - Penal Provisions

Section 1 - Violation of this Ordinance shall be an imprisonment of 30 days or a fine of P 200.00 or both at the discretion of the Honorable Court.

Article III - Effectivity

This Ordinance shall take effect upon approval.
