Municipal Ordinance No. 67, s. 1977

AN ORDINANCE PROHIBITING THE SELLING AND PURCHASE OF ANIMAL MANURE IN THIS MUNI-  
CIPALITY AND THE TRANSFERRING OF ANIMAL MANURE OUTSIDE THE GEOGRAPHICAL JURISDIC-  
TION OF TIGBAUAN, ILOILO AND PROVIDING PENALTY FOR THE VIOLATION THEREOF AND FOR  
OTHER PURPOSES.

BE IT ORDAINED by the Members of Sangguniang Bayan, Tigbauan, Iloilo that:

Article I - Name and Title of Ordinance

Section I - An Ordinance Prohibiting the Selling, and Purchase of Animal  
Manure and the Transferring of Animal Manure in the Municipality of Tigbauan,  
Iloilo,

Section II- Hereinafter no person shall sell or buy animal manure in the  
municipality of Tigbauan, Iloilo,

Section III - No person shall transfer animal manure outside the geographi-  
cal jurisdiction of the Municipality of Tigbauan, Iloilo,

Section IV - All Barangay Head and Barangay Councils are hereby authorized  
to campaign and implement this Ordinance in their respective barangays.

Article II - Penal Provisions

Section I - Violation of the provisions of this Ordinance shall be a fine  
of fifty (P50.00) pesos to one hundred (P100.00) pesos or an imprisonment of 1  
to 10 days or both upon the discretion of the Honorable Court and the confiscation  
of the manure in favor of the municipality by proper authorities.
