Attendance was checked by the Secretary. Reading of the previous
minutes followed.

The approval of the Honorable Secretary of the Bureau of Fisheries and Aquatic Resources was read to the body.

The separation of speed limit and ordinance in Municipal Ordinance No. 4 s. 1966 was recommended during the meeting of the Tar-
advisory Council. It was also suggested in said meeting that cur-
few be imposed on minors or those below 11 years of age unless
accompanied by parents or guardians. This was put into action by

Resolution No. 67, s. 1977

RESOLUTION TO REGULATE THE SPEED AND UNDESERVING DRIVING OF MOTOR AND OTHER KINDS OF MOTOR MACHINES OR VEHICLES TRAVELING ON THE NATIONAL AND PROVINCIAL HIGHWAYS AND MUNICIPAL STREETS WITHIN THE BOUNDARIES OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, PHILIPPINES.

WHEREAS, due to oftentimes over-speeding and reckless
driving by some chauffeurs, accidents happen, resulting in
destruction of property and loss of lives and/or limbs of some
passengers and pedestrians;

WHEREAS, to discourage over speeding of reckless driving
and to better safeguard properties and the loss of Lives and limbs
of the riding public as well as pedestrians;

Ordinance No. 72, 1977

A. ORDINANCE REGULATING THE USE AND OPERATION OF MOTOR VEHICLES AND PROHIBITING THE NOISE AND POLLUTION OF THE ENVIRONMENT CAUSED BY THESE VEHICLES, ESPECIALLY SCOOTERS AND TRICYCLES BY RESTRICTING THE USE OF SCOOTERS OR TRICYCLES IN THE STATE OF KERALA.

Signature - This ordinance shall be known as Ordinance Regulating the unnecessary sounding of horns of Motor Vehicles and reducing the nuisance caused by the loud noise of engines of these Motor Vehicles especially scooters and tricycles.

Sec. 1 - The unnecessary sounding of horns of motor vehicles and nuisance caused by loud noise of engines especially scooters and tricycles are hereby prohibited.
