Municipal Ordinance No. 2, s. 1978

AN ORDINANCE IMPLEMENTING THE TRAFFIC PLAN FOR MCH AND PUJ VEHICLES
IN THE MUNICIPALITY OF TIGBAUAN, ILOILO.

Be it enacted by the Sangguniang Bayan, Tigbauan, Iloilo that:

Sec. 1.1 - This Ordinance shall be known as an Ordinance Implementing the Traffic Plan for MCH and PUJ Vehicles in the Municipality of Tigbauan, Iloilo.

Sec. 2.1 - That the Traffic Plan for MCH and PUJ Vehicles in the Municipality of Tigbauan, Iloilo designates the following as parking areas of:

-A-

- 1) Allera Street facing the Public Market for MCH vehicles plying the Poblacion to Atabayan route;
- 2) The Northeastern corner of the Church compound for MCH vehicles plying the Poblacion to Cordova route;
- 3) The Southwestern portion of T.orro Street facing the western gate of the Public Market for MCH vehicles plying the Poblacion to Bayuan and Baydap routes;
- 4) The corner of eastern Tegore and Tupas Street for PUJ vehicles plying the Poblacion to Iloilo City.

-B- Flow of Traffic

- 1) Portion of Tegore Street facing and at the rear of the Municipal Hall closed to MCH and PUJ traffic;
- 2) a - MCH vehicles from Poblacion to Cordova from parking area to destination should pass in front of the church to Taldelore street down to Tupas Street and turn left to Tuvon Street;

- b- MCH Vehicles from Poblacion to Bayu-an or Dapdap should pass either rear or in front of the church and turn left to Talmelore Street;
- 3) MCH Vehicles from Poblacion to Atabayas - should pass Allera Street move down to Leonardia Street and turn left to Tupas Street;
- 4) PUJ Vehicles from Poblacion to Iloilo City - from Tegero Street to Tupas Street.
- c- No Loading or Unloading Signs - 6 meters from intersections and
 - 1. Corner in front of Caltex Station
 - 2. Corner of Tupas and Tegero Streets
 - 3. Corner of Tegero and Rivas Streets

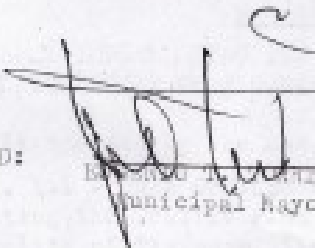
Sec. 3.1 - Non-compliance of this Ordinance imposes a fine of Ten (₱10.00) Pesos or an imprisonment of four (4) days or both upon the discretion of the Honorable Court.

Sec. 4.1 - This Ordinance shall take effect upon approval.
