Municipal Ordinance No. 6, S. 1979					

AN ORDINANCE REQUIRING DOG OWNERS IN THE MUNICIPALITY TO HAVE THEIR DOG IMMUNIZED AND TO TAG THEM AFTER IMMUNIZATION.

SECTION 1 - This is Known as an Ordinance Requiring Dog Owners In The Municipality To Have Their Dog Immunized And To Tag Them After Immunization.

SECTION 2 - Dog owners in the Municipality of Tigbauan are hereby required to have their dogs immunized and to tag them after immunization.

SECTION 3 - Any dog owner who fails to immunize and tag his dog after immunization in violation to this ordinance shall be punished by a fine of not less than ten (P10.00) pesos but not more than fifty (P50.00) pesos or an imprisonment of not less than one day or more than five days, or both at the discretion of the court.

SECTION 4. - This ordinance shall take effect upon approval.
