SECTION 1 - An Ordinance To Prohibit The Scattering Of Chewed Sugar Cane Or Any Form Of Sugar Cane Trash, Peanut Peelings, Candy Wrappers Or Any Kind Or Rubbish Or Garbage In All Public Places Like The Public Market, Public Plaza, Municipal Building And School Environs, Streets And Others.

SECTION 2 - Vendors as well as the general public area hereby prohibited to scatter chewed sugar cane or any form of sugar cane trash, peanut peelings, candy and food wrappers or any other kind of rubbish or garbage in all public places like the Public Market, Public Plaza, Municipal Building and school environs, streets and others.

SECTION 3 - Violation of this ordinance shall be punished with a fine of twenty (P20.00) pesos or an imprisonment of two (2) days or both at the discretion of the Honorable Court.

SECTION 4 - This Municipal Ordinance shall take effect upon approval.
