Municipal Ordinance No. 9, S. 1980

AN ORDINANCE PROHIBITING THE SERVING AND OR DRINKING OF BEER AND OTHER INTOXICATING DRINKS IN  
BEER GARDENS/STORES INSIDE THE PUBLIC MARKET OR OTHER BUSINESS ESTABLISHMENTS IN THE  
MUNICIPALITY AFTER TEN O’CLOCK IN THE EVENING.

SPONSORED BY: Honorable Benjamin Taasan  
SECONDED BY: Unanimously

SECTION 1 - An Ordinance Prohibiting The Serving And Or Drinking Of Beer And Other Intoxicating  
Drinks In Beer Gardens/Stores Inside The Public Market Or Other Business Establishments In The Municipality  
After Ten O’clock In The Evening.

SECTION 2 - The server who violates this ordinance shall be punished with a penalty of fifty (P50.00)  
pesos or an imprisonment of five days or both at the discretion of the Honorable court.

SECTION 2.1 - The drinker who violates this ordinance shall be punished with a penalty of fifty (P50.00)  
pesos or an imprisonment of five days or both at the discretion of the honorable court.

SECTION 3 - This Municipal Ordinance shall take effect upon approval.
